The Officer-in-Charge, Chitpur PS has forwarded the final report under section 173 of the Code of Criminal Procedure, 1973 submitted by the IO vide charge sheet no 79 dated 27-06-2020 punishable under section 401 (A) of the Kolkata Municipal Corporation Act, 1980 against the accused **Srimanta Jana @ Srimanta Kumar Jana, Anita Das @ Khuku Das Bhairagi Bhattacharjee, Rekha Bhattacharjee, Chitta Ranjan Bhattacharjee, Tanmay Bhattacharjee and Santu Mistri** along with relevant documents on which the prosecution proposes to rely and the statements recorded under section 161 of the CrPC of all the persons whom the prosecution proposes to examine as its witnesses.

Scrupulously scrutinized the report and accompaniments by applying judicial mind.

Upon such careful consideration and exercise of sound judicial discretion to the facts and circumstances of the case and materials placed it appears that the investigation of this case has culminated in the above mentioned final report. With this final report the investigation has come to its natural end. The facts and allegations, set out in the final report, have constituted the above mentioned offence.

Ld. A.P.P submitted that there are some vital documents required for proper adjudication in this case and prayed for passing necessary order.

Accordingly, O.C, Chitpur P.S is directed to cause further investigation in this case through an officer of his choice and submit report of investigation positively before this Court on the next date.

The case docket is returned to the I.O to place the same before such officer who is going to conduct further investigation in this case.

While, this Court appreciates the observations made by Ld. Assistant Public Prosecutor regarding the manner in which the investigation should proceed, however, in consideration of the fact that this Court does not have the mandate to direct the manner in which the investigation should be carried out, this Court is not inclined to pass any directions in that line.
