**CHARGES WITH THREE HEADS**  
[No. XXVIII (II), SCHEDULE V, Act V, 1998]  
(Sections 221, 222, 223, Code of Criminal Procedure)

(1) Name and office of Magistrate, &c. I, **Smt. Sneha Basu, Municipal Magistrate, 4th Court, Calcutta-in-charge** do hereby charge you<sup>(2)</sup> **(1) Tina Seal, (2) Kishor Sadhukan, (3) Biswajit Sadhukan & (4) Netai Ch. Mondal**

(2) Name of accused person as follows:

That you on or before **02.02.2022**, being the persons responsible was engaged in making unauthorized construction of building at premises No. **4&5, Uma Charan Mitra Lane, Kolkata-03, P.S. Shyampukur, Br-I, Ward- 07** without sanction plan and if allowed to stand, may collapse at any date, endangering human life and water supply, drainage, sewerage of road or road traffic and may cause fire hazard

and thereby committed an offence punishable under **Section 401A** of the of Kolkata Municipal Corporation Act and within the cognizance of this Court.<sup>(3)</sup> being the persons responsible was engaged in making unauthorized construction of building at the same date, time and place without any sanctioned plan and thereby committed an offence punishable under **Section 392/610** of the of Kolkata Municipal Corporation Act and within the cognizance of this Court.<sup>(3)</sup> being the persons responsible was engaged in making unauthorized construction of building by violating stop work notice at the same date, time and place, in contravention of the provisions of the KMC Act

(3) My cognizance or the cognizance of the Court of Session. and thereby committed an offence punishable under **Section 618** of the of Kolkata Municipal Corporation Act and within the cognizance of this Court.<sup>(3)</sup>

(4) In cases tried by Magistrate, omit "by the said Court."

And I hereby direct that he be tried <sup>(4)</sup> by the said Court on the said charge. Contents of the charge is read over and explained to all the four accused persons. On being asked, to the all the four accused persons, pleaded not guilty by saying "**Ami nirdosh**" separately and claimed to be tried.
