	13.04.2023	<p>Today the record is put up at the petition of Ld. Counsel for the Defence. Both parties are present. Accused Pritam @ Pratik Chakraborty surrenders before this court. He is taken into custody.</p> <p>Ld. Defence Counsel submits that a W/A was issued against the said accused person in connection with this case and that the accused person was arrested on the strength of said warrant and thereafter released on bail by Ld. Additional Chief Judicial Magistrate, Barrackpore, North 24 Parganas. Ld. Defence Counsel further submits that the accused was directed to be present before this court which will ensue confirmation of the interim bail granted to him.</p> <p>Ld. APP raises formal objection.</p> <p>Heard the submission of Ld. Counsel for both the sides and considered the same. Perused the materials on record.</p> <p>On perusal of the documents attached along with the petition, it transpires that on 11.04.2023 the accused person was released on interim bail by Ld. Additional Chief Judicial Magistrate, Barrackpore, North 24 Parganas in execution of W/A issued by this court. The other half of submission made by the Defence seems to be fortified by the order sheet as well.</p> <p>Accordingly, in consideration of the aforementioned observations, the prayer of the accused person is allowed. Ld. Defence Counsel is directed to submit personal recognizance bond on behalf of accused person of Rs.1000/- with this case record. Released the accused person at once if detention is not warranted in connection with any other case.</p> <p>At this juncture Ld. Defence Counsel prays for supply of the copy which according to him is with the case record and has not been received by him.</p> <p>On perusal of the case record admittedly, it transpires that copy of the charge sheet as well as allied documents u/s 173(5) of Code of Criminal Procedure, 1973 is appended with record.
