Today is fixed for appearance and further order

Accused namely Akil Rashid (A-1) and Md. Ziaulhuda are absent by petition through their Ld. Counsel and both the accused are on bail vide order dated 27.02.2019 and 17.08.2024 respectively.

Accused namely Md. Salim (A-2) is on bail vide order dated 27.02.2019 and present today with his Ld. Counsel.

Accused namely Parveen Begum (A-3), Yasmin Begum (A-4), Shamima Begum (A-5) and Ismat Begum (A-6) are present today filing hazira along with their Ld. Advocate and intends to surrender before the court. They are taken into custody.

Ld. A.P.P for the State is present.

Ld. Counsel for accused, namely, Parveen Begum (A-3), Yasmin Begum (A-4), Shamima Begum (A-5) and Ismat Begum (A-6) files a petition along with fresh Vokalatnama with copies of aachar cards and submits that this accused got bail under Section 438 of CrPC.

Upon a consideration of the petition, this court opines that it is in interest of justice that the prayer of the Ld. Counsel for the accused is allowed.

He finally prays for bail.

Heard the Ld. A.P.P.

I have heard submissions of Ld. Counsel for the parties, perused the case record.

Considering anticipatory bail order of the Ld. Sessions Judge, South 24 Parganas, Alipore vide order No. 02 dated 18.01.2021 nature of alleged offence, fact and circumstances of this case, the prayer for bail made by the accused persons are allowed.

Accordingly, accused person, namely, Parveen Begum (A-3), Yasmin Begum (A-4), Shamima Begum (A-5) and Ismat Begum (A-6) be enlarged on bail on furnishing bail bond of Rs. 5,000/- (Rupees Five thousand) only with two sureties of Rs.2500/- each, in default, to Judicial custody.

It appears from the record that accused namely Ashique Ahmed (A-7) has not appeared before the court till date.

At this stage, Ld. Counsel for the accused namely Ashique Ahmed (A-7) files undertake to present the said accused on the next date positively
