Today is fixed for production and appearance of the accused persons.

The Ld. P.P and the Ld. Defence Counsel are present before this Court.

Out of two accused, accused Jagannath Karmakar @ Raja is present by filing hazira alongwith his Ld. Lawyer.

The another accused Goutam Paul is produced from CCH through VC.

Ld. Lawyer for the accused Goutam Paul files Vokatnama alongwith a petition for bail.

Heard both sides.

It appears from the record that on 15-12-2025 these two accused persons got interim bail by this Court as the victim lady was present before the Court and submitted before the Court that she wants to continue her family life as because Jagannath Karmkar is the husband of the de-facto complainant. She further stated that she has no objection if the accused persons are released on bail. The elder brother of the victim lady was also present before the Court on 15-12-2025 and stated that they have talked with the family members of the accused persons who assured them that such type of incident will not be occurred in future.

Considering that situation the interim bail was allowed for both the accused persons upto 05-01-2026. On that date the accused Goutam Paul was not appeared before the Court and nor filed any application for extension of interim bail or filed any petition for time and accordingly the warrant was issued against accused Goutam Paul, who subsequently surrendered before the Ld. CJM, Dakshin Dinajpur on 14-01-2026 and since then he is in custody.

Now the situation is, case has already been committed to this Court. The accused Jagannath Karmakar has already on bail.

From the document as placed by the Ld. Lawyer for the accused Goutam Paul it appears that while he was on bail he duly comply the order of the Court and meet with the I.O as per the direction of the Court.

Considering the situation the prayer of the accused Goutam Paul for bail is considered and allowed.

The accused Goutam Paul may find a bail of Rs.6,000/- with two sureties of Rs.3,000/- each, subject to the satisfaction of the Ld. CJM, Dakshin Dinajpur. The sureties must be other than previous sureties.

If on bail 03-02-2026 for appearance, i.d. to correctional home till 31-01-2026.

The accused Jagannath Karmakar files a petition with a prayer for confirmation of the bail and a separate petition for weaving the thana hazira.

Heard. Considered.

The accused Jagannath Karmakar also placed the document to show that he duly complied with the order of the Ld. Court and comply the conditions.

Considering the same the condition given to the accused Jagannath Karmakar on 15-12-2025 is hereby weaved.

Now the case is ready for transfer. Let the case record be transferred in the Court of the Additional District & Sessions Judge, 2nd Court, Dakshin Dinajpur at Balurghat for disposal

Fix 03-02-2026 for appearance/production of the accused persons before the Ld. Transferee Court.

The Superintendent of BCCH is directed to produce the accused to the Transferee Court on 31-01-2026 physically if he is not availed the bail in the mean time.
