Ld. Advocate for the accused Badal Soren has filed an application, praying for releasing him on bail.

Accused Kaliram Das has been in custody since 20.12.2023. Ld. Advocate for the accused Kaliram Das has also filed an application for releasing him on bail.

Both the petitions are taken up for hearing.

Ld. Advocates for both the accused persons submitted that the accused shall remain present on each and every date of hearing, if bail is granted to them. They have prayed for releasing the accused persons on bail.

Ld. Public Prosecutor in-charge raised strong objection and prayed for rejection of the bail petitions.

Heard both sides.

Perused the bail petitions, C.D and materials available on record.

Considered.

Both the accused were on bail but they misused the liberty of bail.

It transpires from the record that the accused Kaliram Das has been in J.C since 20.12.2023. Thus, having considered the period of detention of the accused in custody, I am inclined to release him on bail.

So far the accused Badal Soren is concerned, having considered his voluntary surrender and considering the undertaking, given by the Ld. Advocate, I am inclined to release him on bail.

Accused namely Kaliram Das, son of Suresh Das, Uttamasha-Palli, P.S. Balurghat and accused namely Badal Soren, son of Ludhu Soren, Dakshin para, P.S. Hili, both of district-Dakshin Dinajpur may find interim bail of Rs.5000/- each with two registered sureties of Rs.2500/- each, subject to the satisfaction of Ld. C.J.M, Dakshin Dinajpur at Balurghat, i.d. to J.C till next date.

Accused is directed to remain present on each and every date of hearing, failing which the interim order shall automatically be vacated.

Custody accused persons namely Shiva Yadav, Narayan Yadav and Kaliram Das are remanded to J.C till next date.
