O R D E R

1. This application for anticipatory bail has been filed by applicant/accused, Puyush Sharma @ Khanyia Sharma son of Shri Satish Sharma, in case FIR No.73 dated 23.05.2015 for offences under

sections 452/427/506/148/149 of Indian Penal Code, registered at Police Station “B” Division, Amritsar.

2. On notice, Public Prosecutor opposed the bail application.

3. I have heard counsel for applicant/accused and the Public Prosecutor for the State and have gone through the record.

4. FIR in this case was registered on the basis of statement of Rama Sharma, mother of applicant Puyush Sharma alias Khanyia Sharma. DDR No.37 dated 31.05.2015 was registered in this very case against the applicant and his two accomplices and 3-4 more unidentified persons on the basis of statement of Kewal Kumar. As per said cross-version, on 23.05.2015 applicant and his accomplices trespassed into the house of Kewal Kumar and damaged the window panes of his house and all of them were armed with different weapons.

5. It appears to be a case of no injury. The applicant joined the investigation with the police on the basis of order of interim bail dated 21.04.2018 passed by this court. The applicant is not required by the police for any further investigation. So, no purpose will be served by sending the applicant in police custody at this stage.

6. Consequently, this bail application is allowed and order of interim bail dated 21.04.2018 passed by this court is hereby made

absolute subject to the conditions which are envisaged under section 438 (2) of Cr.P.C. Papers be consigned to record room.
