Order:-

This order shall dispose of bail application moved on behalf accused/applicant Sukhwinder Singh @ Sukhdev @ Sukha, in FIR No. 64 dated 20.08.2024, U/s. 303 (2), 317 (2) BNS, P.S. Rangar Nangal. It has been submitted in the application that the accused/applicant is innocent and has not committed any offence. It has been further submitted that accused/applicant is declared proclaimed offender vide order dated 27.11.2025, but his absence was neither willful nor intentional, but due to soem unavoidable reasons. Accused/applicant is in judicial custody since more than two months and as such no more custody is required for any investigation and interrogation. As such, it has been prayed that the applicant/accused be released on bail.

2. The Ld. APP for the State has not filed any written reply to the present bail application. The Ld. counsel for the applicant/accused as well as the Ld. APP for the State has been heard. Case file has been perused.

3. Heard. A perusal of the file shows that accused/applicant Sukhwinder Singh @ Sukhdev @ Sukha was on bail in the present case. However, on account of his absence, the bail order of the accused Sukhwinder Singh @ Sukhdev @ Sukha was ordered to be cancelled

vide order dated 28.08.2025 and the accused was eventually declared proclaimed person vide order dated 27.11.2025. It has further transpired that consequent upon his re-arrest the applicant/accused is in custody since 09.01.2026. After going through the file, this court is of the opinion that since his arrest on 09.01.2026, accused/applicant has suffered sufficient custody. Challan in the present case has already been presented. No useful purpose would be served by keeping the accused/applicant in the custody. Hence, in view of the above discussion, the present bail application stands allowed and the accused/applicant Sukhwinder Singh @ Sukhdev @ Sukha, is hereby ordered to be released on bail subject to furnishing bail bonds in sum of Rs. 30,000/- with one surety in like amount.
