Received one Skeleton Record from Addl. Chief Judicial Magistrate, Gangarampur at Buniadpur along with formal FIR, Written Complaint of B.S.P., accused challan, forwarding report, seizure memo of B.S.P., seizure list of P.S., memo of arrest and inspection memo. Let it be kept with the record.

Accused person namely Rubel Mia is produced from J/C physically as he was remanded to J/C till 17-11-2020.

Let a Special Case be registered against the accused persons.

At this stage, It is submitted by the Ld. Advocate of the accused person namely Rubel Mia that the accused person is a juvenile and to this effect photocopy of birth certificate is filed.

It is further submitted by Ld. Advocate that since the accused was born on 05-02-2003, the accused is a juvenile and hence be sent to Juvenile Justice Court, Balurghat.

Ld.P.P in Charge is also present and made his submission. Heard both sides.

On perusal of the photocopy of the document submitted, and respective submissions of the parties, the plea of juvenility of the accused Rubel Mia needs to be determined.

Hence, let the accused Rubel Mia alongwith the placed documents and the requisite case record documents be produced before the Juvenile Justice Board, Balurghat for determination of the plea of juvenility as per the provisions of The Juvenile Justice (Care and Protection of Children) Act, 2015 especially sec.9 & sec.15 of the Said Act and the rules framed thereunder.

The Principal Magistrate, Juvenile Justice Board, Dakshin Dinajpur at Balurghat shall proceed under the provisions of law and report the result accordingly before this Court.

Accused Rubel Mia be produced today before J.J.B, Balurghat, Dakshin Dinajpur along with the stated documents.

Accused person Rubel Mia is sent to J.J.B.

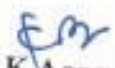
Let a copy of this order be sent to J.J.B, Balurghat, Dakshin Dinajpur for information and necessary action and also to Balurghat Central Correctional Home Balurghat for information and records.

To 17-11-2020 for production of the accused person Rubel Mia before J.J.B, Balurghat, Dakshin Dinajpur.

Since the accused is sent to J.J.B, Balurghat, Dakshin Dinajpur for determination of plea of juvenility and there remains another FIR named accused persons yet to be arrested, let the next date of the instant case be fixed on 03-01-2021 for receipt of report from J.J.B, Balurghat, Dakshin Dinajpur and for further report from IO regarding accused persons not yet apprehended.
