COMMITMENT ORDER:

1. The above-mentioned accused persons have been sent by the Station House Officer, Police Station Sampla, Rohtak to face trial for the commission of offence punishable under Sections 115, 190, 191(3), 333, 351 (3), 109 (1), 117 (2) BNS.

2. The present case is based upon the complaint of Sh. Aman son of Sh. Balwan, who reported that they are three brothers and all of them lived together. On 26.03.2026, he went to the New Grain Market, Sampla to sell his mustard crop in the tractor-trolley of Narender son of Raghuvir, from his village. After unloading the mustard crop, he and Krishan son of Ram Chander, from his village, were sitting at shop No. 103 in the Grain Market. He lay down on a cot inside the shop. At around 01:45 p.m., Ajay son of Anup and Akshay son of Anup both from his village alongwith three other associates arrived and they were armed with wooden sticks (dandas) and iron rods. They started assaulting him. They causes serious injuries to both his legs and hands. When he raised an alarm, Krishan came to rescue him. The accused threatened to kill him and fled from the spot. He was got admitted in hospital. He requested to registered a case and strict action be taken against assailants. On the basis of this complaint, FIR under Sections 115, 190, 191(3), 333, 351 (3), 109 (1), 117 (2) BNS was registered. On completion of investigation, challan/report under Section 193 BNSS was presented in the Court.

3. Copy of challan alongwith documents annexed thereto were supplied free of cost as envisaged under section 230 BNSS.

4. I have heard learned APP for the State and learned defence counsel and have gone through the case file carefully.

5. From the perusal of the final report including documents appended herewith, the accused persons prima-facie appeared to have committed the offence punishable under Sections 115, 190, 191(3), 333, 351 (3), 109 (1), 117 (2) BNS. The offence under Section 109 (1) of BNS is exclusively triable by the court of session. Therefore, the present case is, hereby, committed to the court of Learned Sessions Judge. As per provision envisaged under section 232 BNSS accused Sahil, Ajay, Akshay and Rocky @ Prince who are on bail are directed to appear before the court of Learned Sessions Judge, Rohtak on **03.08.2026** at 10:00 AM sharp. District Attorney stands notified about this order through Assistant Public Prosecutor of this court. Reader is directed to prepare calendra. Concerned Ahlmad is directed to send the case file to the Court of learned Sessions Judge, Rohtak immediately complete in all respect.
