ORDER NO. 01

Accused person namely Sirina Bibi and Subrata Mondal is produced before this Court from Balurghat P.S along with along formal FIR, seizure List of P.S, Memo of arrest, Inspection memo duly endorsed by Medical Officer, Balurghat District Hospital and accused challan. Let the documents be kept with the case record.

Accused person namely Sirina Bibi and Subrata Mondal is taken into custody.

Let the case be registered against the accused person as NDPS Case.

Two separate bail petitions along with Vokatnama is filed for accused persons upon serving copy.

Ld. Advocate prays for bail of the accused on the grounds of non-absconion which is opposed by the Ld. P.P. as the case at investigation stage.

Upon consideration of the submission of both sides and considering the mandatory bar under the provision of NDPS Act, the prayer for bail of accused Sirina Bibi and Subrata Mondal is hereby rejected.

CD is produced. I.O is present. Heard I.O.

Perused the CD and the forwarding report produced today by the police wherein the police has prayed for Police Custody for the accused Sirina Bibi and Subrata Mondal for 05 days by SI SDilip Kumar Singha of Balurghat P.S duly forwarded & recommended by superior authorities on the grounds stated therein and seen by Ld.P.P.

Considering the materials available in the CD, the prayer of police custody of the accused person namely Sirina Bibi and Subrata Mondal is hereby allowed till 12.04.2024.

I.O. is directed to ensure that utmost care and caution be taken so that the accused persons are not manhandled in any manner whatsoever and to provide them

with all possible medical assistance if needed, during the period of police remand. The accused persons must be taken for medical check up on each day during police remand. The accused Sirina Bibi taken in PC by the IO accompanied by Lady Home Guard and IO is further directed to maintain decency of the accused. The lady accused if required be interrogated in presence of Lady Home guard or Constable and always move with assistance of Lady Home guard and Constable.

I.O. is further directed to observe strictly the guidelines set out by the Hon'ble Apex Court of India in this behalf regarding police custody in D. K. Basu Vs State of West Bengal (1997) 1 SCC 416.

Accused person namely Sirina Bibi and Subrata Mondal is hereby remanded to **Police Custody till 12-04-2024.**

To **12-04-2024** for production of the accused person namely Sirina Bibi and Subrata Mondal from Police Custody with P.C Report along with CD and report in final form.

Let a copy of this order be handed over to I. O. SI Dilip Kumar Singha of Balurghat P.S.
