The sole accused namely Krishna Pahan is produced from Balurghat Central Correctional home through V.C.

Today is fixed for evidence as per schedule.

Ld. Advocate (LADCs) for the accused is present.

Ld. P.P. in-charge files hazira of two witnesses namely ASI Nibaran Murmu (C.S.W.14) and Dr. Mousumi Rakshit (C.S.W.1 of 2nd charge sheet), who are examined-in-chief as P.W.12 and P.W.13 (through V.C) respectively. They are cross examined in-full and discharged.

During the evidence of P.W.12 the receiving endorsement along with signature and seal on the written complaint by S.I Satkar Syngbo of Patiram P.S. is marked Ext.P-1/2, the Formal FIR is marked as Ext.P-2, the signature of SI Raj Kumar Basak on the formal FIR is marked as Ext.P-2/2, the signature of S.I Satkar Syngbo O.C of Patiram P.S on the formal FIR is marked as Ext.P-2/3, the rough sketch map is marked as Ext.P-13 and the index is marked as Ext.P-13/1 respectively.

During the evidence of P.W.13 the report of the witness (Sr. Scientific Officer RFSL) is marked as Ext.14, the signature of the witness is marked as Ext.14/1, the said requisition prepared and signed by me dt.30.09.2024 which is marked as Ext.15 and the Serologist report dt.03.12.2024 is marked as Ext.16 respectively.

At this stage Ld. P.P in-charge files a petition praying for exhibiting the statements u/s.164 Cr.P.C of Kanika Pahan and Khitish Pahan u/s.294 Cr.P.C on the ground stated therein. Let the petition be kept with the record for hearing.

No other witness is present.

The case is adjourned today fixing fresh schedule.

To **10.02.2026** for evidence of C.S.W.13 & 16, 1st Charge Sheet **dt.25.03.2023**.

Prosecution is to take steps towards issuance of summons to the witnesses according to the above mentioned schedule positively.

Prosecution shall produce the witnesses and alamats on the dates of evidence, if any so that schedule does not fail.

Accused is remanded to J.C till next date.

To date (**07-01-2026**) for evidence, hearing the petition u/s.294 Cr.P.C and production of accused person.
