Name and office of Magistrate, &c.	I, Smt. Sharanya Sen Prasad, Additional Sessions Judge, 2 nd Court, Balurghat, Dakshin Dinajpur hereby charge you,as follows :-
Name of accused persons	Pabitra Roy
State the offence	Firstly : - That you on 12.11.2025 at about 10:00 hours at village Nazarpur (Laxmi Narayanpur), under PS Tapan, District Dakshin Dinajpur wrongfully restrained the victim lady and that you thereby committed an offence punishable under Section 126(2) of the BNS , and within the cognizance of this court .
State the offence	Secondly :- That you on12.11.2025 at about 10:00 hours at village Nazarpur (Laxmi Narayanpur), under PS Tapan, District Dakshin Dinajpur committed rape upon the victim lady and that you thereby committed an offence punishable under Section 64(1) of the BNS , and within the cognizance of this court .
State the offence	Thirdly : - That you on 12.11.2025 at about 10:00 hours at village Nazarpur (Laxmi Narayanpur), under PS Tapan, District Dakshin Dinajpur by sending anonymous communication with a view to threat to the victim lady 'X' with injury to her person and her family members, if she divulged anything to anyone and that you thereby committed an offence punishable under Section 351(3) of the BNS , and within the cognizance of this court .
State the offence	And I, hereby direct that you be tried by the said Court on the said charge.
In cases tried by Magistrate omit "by the said Court."	The above mentioned charge is read over and explained to the accused person to which he pleaded not guilty of offence and claimed to be tried.
