State the offence

Firstly : - That you on 29.08.2023 at about 09:00 hours on way at Khadimpur Taltala near Sukanta Colony, under PS Balurghat, under PS Balurghat, District Dakshin Dinajpur in furtherance of common intention wrongfully restrained victim lady and that you thereby committed an offence punishable **under Section 341/34 of the Indian Penal Code**, and within the **cognizance of this court**.

Secondly :- That you on 29.08.2023 at about 09:00 hours on way at Khadimpur Taltala near Sukanta Colony, under PS Balurghat, under PS Balurghat, District Dakshin Dinajpur and later on 30.08.2023 at about 10:00 hours in the house of victim lady at Khadimpur Taltola, under PS Balurghat in furtherance of common intention voluntarily caused hurt to victim lady and Surajit Das with injury to their persons and that you thereby committed an offence punishable **under Section 323/34 of the Indian Penal Code**, and within the **cognizance of this court**.

Thirdly :- That you on 29.08.2023 at about 09:00 hours on way at Khadimpur Taltala near Sukanta Colony, under PS Balurghat, under PS Balurghat, District Dakshin Dinajpur tried to commit gang rape upon the victim lady and that you thereby committed an offence punishable **under Section 376D/511 of the Indian Penal Code**, and within the **cognizance of this court**.

Fourthly :- That you on 29.08.2023 at about 09:00 hours on way at Khadimpur Taltala near Sukanta Colony, under PS Balurghat, District Dakshin Dinajpur in furtherance of common intention committed criminal intimidation by sending anonymous communication with a view to threat the victim lady with injury to her person if she divulged anything to anyone and that you thereby committed an offence punishable **under Section 506/34 of the Indian Penal Code**, and within the **cognizance of this court**.

And I, hereby direct that you be tried by the said Court on the said charge.
