Record is put up today.

The accused Sunil Karmakar surrendered today against whom W.A has been issued by this Court vide order No.7 dt.01.12.2025.

Recall W.A.

One bail application is submitted on behalf of the accused Sunil Kamakar with a prayer for releasing him on bail on any terms and condition.

Ld. P.P in-charge and Ld. Advocate for the accused person is present.

Let the application be taken up for hearing.

Heard both sides.

Ld. Advocate for the accused person submits that on the last occasion the accused did not appear before the court as he was not informed due to diary mistake, as such W.A was issued against him. He also submits that the accused person is a permanent resident of said address and there is no chance of absconding if bail is granted.

Perused the case record.

It transpires from the record that the accused was absent without any steps on the date of his appearance and framing of charge. None appeared on behalf of the accused Sunil Karmakar inspite of repeated calls and surety also failed to produce the accused. The conduct of the accused has caused unnecessary delay due to his unauthorized absence along with his Ld. Advocate, for which W.A was issued against him.

Subsequently, today the accused person voluntarily surrendered before this Court with a prayer for bail.

Now, I find that there is no constable deputed in this Court room for taking the accused in custody if his prayer for bail is rejected. It is now 11-10 a.m.

Under such circumstances, I am inclined to enlarge the accused namely Sunil Karmakar, son of Late Priyanath Karmakar, resident of Khadimpur Girls' School Para, P.S.Balurghat, Dakshin Dinajpur on A.I bail of Rs.5000/- with two registered sureties of Rs.2500/- each subject to the satisfaction of Ld. C.J.M., Dakshin Dinajpur, i.d to J.C till next date.

Accused is directed to remain present on each and every date of hearing, failing which the interim order shall automatically be vacated.
