	<u>18.08.26</u>	This is a regular bail petition filed on behalf of accused petitioner namely Vijay Kumar @ Vijay Kumar Saw, who is in judicial custody in connection with Keredari P.S. Case No.76/2026 registered U/s. 69/108/ 3(5) of B.N.S. since 13.06.2026 pending in the Court of Sri Kumar Vipul, Ld. J.M. 1st Class, Hazaribagh, pressed for hearing after serving copy of the petition to Ld. PP for the State. Heard both the parties. Ld. defence counsel has submitted that the accused petitioner is innocent and committed no offence. He has filed regular bail petition before this Court for the first time after rejection of his prayer for bail by the Court of Sri Kumar Vipul, Ld. J.M. 1st Cass, Hazaribagh on 22.07.2026. The entire allegation made against the accused petitioner in the FIR is false, fabricated and manufactured piece of evidence. The accused petitioner has not committed any offence as alleged in the case and hence none of the ingredients of the offence U/s. 69 & 108/3(5) of BNS attracted against him. Further so far as offence U/s. 108 of BNS is concerned, there is neither direct or indirect evidence against this

accused petitioner in making instigation or abatement by him is on the record and he is a permanent resident of this District and law abiding person undertakes to abide by all the terms and conditions for his bail. He is the sole earning member of his family and his family is facing much financial hardship at present and in this way Ld. defence counsel has made prayer to enlarge him on bail.

Ld. PP for the State has vehemently opposed the prayer for bail made on behalf of accused petitioner stating that the case is very serious in nature in which the victim girl (deceased) has been compelled for her suicidal death by hanging and the vicim has stated everthing in her suicidal notes and at present investigation is running and her suicidal notes has been sent to FSL, Ranchi and the photocopy of the same is enclosed with the FIR which clearly shows that the victim was very much under mental trauma due to the pressure imposed upon her by the accused and after committing physical relation with her, he refused to marry her and his family members have instigated him to refuse the victim girl and that was the cause of her death and the informant has stated everything in his re-statement which the I.O. has recorded with the statement of witnesses in the case diary vide para 3, 4, 11, 12, 13 & 14 of the case diary. incriminating material has also been prepared at the spot which the I.O. has mentioned in para 15 of the case diary and the statement of witness Lata Kumari U/s. 183 of BNSS has also been recorded vide para 42 of the case diary and the electronic evidence with pen drive has also been produced with certificate on the record vide para 50 of the case diary and accused has confessed his guilt in his confessional statement vide para 68 of the case diary and sample of the incriminating material has been sent to FSL vide para 76 of the case diary and investigation is running further to get forensic evidence and other things on the record. So at this stage there is ample chances of absconding of the accused petitioner with tampering of the evidence and his custodial trial is required in this case.

Heard and perused the case record. The case of the prosecution is based upon written report of the informant (father of the deceased) who lodged written report before Officer-in-Charge, Keredari P.S. in which he has stated that his daughter (victim girl) died due to her suicidal death hanging over ceiling fan with roof of the house on 13.05.2026 at about 12.00 O'Clock in the evening hour. When they found the victim girl hanging with the ceiling fan in unconscious state and then they immediately took her to Sadar Hospital, Hazaribagh where from she

has been referred to Arogyom Hospital, Hazaribagh but she was found very much in critical condition and hence on 21.05.2026 they took her to Orchid Hospital, Lalpur Chowk, Ranchi and further to RIMS, Ranchi on 26.05.2026 when in due course of treatment she unfortunately died. Then on 09.06.2026 in course of search her Adhar card, hand written notes recovered from her college bag dated 29.09.2024 when the fact revealed that she got love affairs with a person namely Vijay Kumar Saw (the present accused petitioner), S/o Suresh Saw, R/o Village Kandber, P.S. Keredari, District Hazaribagh since before two years and he regularly made contact with her with physical relation giving allurements to marry her but later on he refused to accept her. The victim girl has stated everything to her parents that Vijay Saw forcibly committed physical relation with her and then they went to the place of Vijay Kumar Saw when his family members (Vijay Kumar Saw, Suresh Saw and his wife) gave assurance to marry the victim girl after a year of construction of their house. But they flatly refused later on in the year 2025 and abused and humiliated the family members of the victim girl and then the victim girl went in mental trauma and tried to commit suicide by hanging in the evening hour at about 12.00 O'Clock on 13.05.2026 and in due course of treatment in

RIMS, Ranchi she died at about 3.30 on 12.06.2026 and hence the case.

In this case the informant in his re-statement and the witnesses have given their statement U/s. 180 of BNSS to the I.O. vide para 3, 4, 11, 12, 13, 14, 35, 50 of the case diary. One of the friends of the victim has also given his statement disclosing the fact that the deceased was class friend of Vijay Kumar who has compelled her for suicidal death. The suicide note of the deceased also enclosed with the FIR and the original copy has been sent to FSL for forensic examination. So there appears ample material on the record to connect prima-facie chain for the complicity of the present accused for the cause of death of the deceased and the matter is still under investigation. So at this stage there is ample chances of absconding of the accused petitioner with tampering of evidence with an intention to delay the investigation in this case and his custodial trial is very much required.

So considering the aforesaid facts and circumstances of the case coupled with seriousness and gravity of the offence running at the stage of investigation, I am not inclined to enlarge the aforesaid accused petitioner on bail and accordingly the prayer for bail made on behalf of the accused petitioner namely **Vijay Kumar @ Vijay Kumar Saw,**
