The applicant/accused was granted interim bail vide order
dated 09.06.2021, with the direction to join the investigation.

Investigating Officer ASI Kashmir Singh No.3368/Btl has
appeared in the Court and stated that the applicant/accused Jugraj Singh
@ Jogga Singh has joined the investigation on 14.06.2021 and he is not

required for further custodial interrogation in this case. His statement has been recorded to this effect.

Keeping in view of the statement of ASI Kashmir Singh No.3368/Btl, since the applicant/accused has joined the investigation in pursuance of the order dated 09.06.2021, no purpose would be served by sending him in judicial detention. Therefore, the order dated 09.06.2021, vide which the applicant/accused was granted interim bail, is made absolute, subject to the terms and conditions that:-

- i) the applicant shall make himself available for interrogation before the SHO/Investigating officer, as and when required; and
- (ii) the applicant shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case, so as to dissuade him/her from disclosing such facts to the investigating officer/any police officer or to the Court.

Copy of this order be sent to the concerned police station for information. Police file be returned. File of bail application be consigned to the record room after due compliance.
