1. Arguments on bail application heard.
2. The present bail application has been moved on behalf of the applicant/accused on the ground that the applicant/accused has been falsely implicated in this case. It is submitted that Hon'ble Court already granted bail of the accused in the FIR No.257 dated 29.11.2024. It is also submitted that the Hon'ble Court has already granted bail of the co-accused Ram Sewak on 16.01.2025 in the present FIR. It is further pleaded that applicant/accused is totally innocent and he has committed no offence. It is further pleaded that it will take time for conclusion of trial and no useful purpose will be served by keeping accused behind bars.

It is further pleaded that the applicants/accused shall abide by all the terms and conditions imposed by this Court, if the liberty of bail is granted to the accused.

3. Notice of the bail application was given to the learned APP for the State, who did not file any written reply and orally opposed the bail application with prayer to dismiss the same.

4. Perusal of record transpires that accused-applicants are in judicial custody since 06.12.2024. The presentation of challan and trial of the case is likely to take long time. No useful purpose will be served by keeping the accused-applicant in custody. Keeping the accused further in custody shall only a burden on State Exchequer. Moreover, bail and not jail is the rule of law. Hence, accused/applicant is ordered to be released on bail on their furnishing personal bail bonds in the sum of **₹ 75,000/- with one surety in the like amount**, subject to following conditions:-

- (i) The accused/applicant shall remain present before the Court on each and every date of hearing.
- (ii) The accused/applicant shall not influence the witnesses of the prosecution nor shall try to intimidate or threaten the witnesses of the prosecution.
- (iii) The accused/applicant shall not leave India, without intimation and prior permission of the Court.
- (iv) The accused/applicant shall not commit similar kind of offence during the pendency of the present case.

Bail application stands disposed of accordingly. Ahlmad is

directed to sent the copy of bail order to the Jail Superintendent. Police record be returned. Personal bail bonds and surety bond not furnished. Papers be attached with the remand papers/main file.
