Case record is put up today. The Ld. Advocate of the accused person namely Mokram @ Mokram Hossain has filed a Vakalatnama, surrender cum bail petition alongwith a certified copy of an order dated 15.12.2020 passed by the Hon'ble High court, Calcutta in CRM No.10372 of 2020.

The accused person is present in person in Court today alongwith the Ld. Advocate of the accused person. Copy served upon the Ld. P. P. in charge.

Ld. Advocate of the accused person submitted that the Hon'ble High court, Calcutta has been pleased to grant anticipatory bail to the accused person namely Mokram @ Mokram Hossain U/S. 438 of Cr. P. C in terms of the order dated 15.12.2020 passed by the Hon'ble High court, Calcutta in CRM No.10372 of 2020 and as such the accused person namely Mokram @ Mokram Hossain begs to surrender before this Ld. Court today and prays for bail of the accused person.

Ld. P. P. in charge submitted that in the instant case, Charge Sheet has been filed and the present accused namely Mokram @ Mokram Hossain is charge sheeted as accused No. 9 and in view of the submissions of the Ld. Advocate of the accused person and in view of the Order passed by the Hon'ble High Court, Calcutta, necessary orders may be passed by this Ld. Court.

Upon perusal of the certified copy of an order dated 15.12.2020 passed by the Hon'ble High court, Calcutta in CRM No. 10372 of 2020, it is seen that it has been ordered by the Hon'ble High court, Calcutta that in the event of arrest, the petitioner be released on bail upon furnishing bond of Rs. 10,000/- (Ten Thousand Only), with two sureties of like amount each.

Considered the documents placed before this Court, considered the submissions made by the Ld. P. P. In charge and the submissions made by the Ld. Advocate of the accused person and upon considering the respective submissions made by the parties, the accused person namely Mokram @ Mokram Hossain be released on bail upon furnishing bond of Rs. 10,000/- (Ten Thousand Only), with two sureties of like amount each, subject to conditions as laid down in the order of the Hon'ble High Court.
