Accordingly charge is framed against the accused Bhabesh Chandra Das for offence punishable under sections 329(4)/115(2)/117(2)/74/64/62/3(5) of BNS and against Kushum Das & Jagadish Chandra Das for offence punishable under sections 329(4)/115(2)/117(2)/3(5)of BNS .

The content of the charge is read over and explained to the accused persons, in Bengali, to which they pleaded not guilty by saying “Ami Nirdosh” and claims to be tried.

***Secondly* :-** That you on 13.05.2025 at about 10:00 hours at Osail, Dinapakura, under PS Balurghat, District Dakshin Dinajpur in furtherance of common intention assaulted the complainant's mother, complainant's sister-in-law, Dipak Das and Mithun Das and that you thereby committed an offence punishable **under Section 115(2)/3(5) of BNS**, and within the **cognizance of this court.**

Secondly :- That you on 13.05.2025 at about 10:00 hours at Osail, Dinapakura, under PS Balurghat, District Dakshin Dinajpur entered upon the property of the complainant's brother and assaulted or used criminal force to the sister-in-law of the complainant intending to outrage or knowing it to be likely that he will thereby outrage her modesty and committed rape upon her and that you thereby committed an offence punishable **under Section 64 of BNS**, and within the **cognizance of this court.**

Thirdly :- That you on 13.05.2025 at about 10:00 hours at Osail, Dinapakura, under PS Balurghat, District Dakshin Dinajpur entered upon the property of the complainant's brother and assaulted or used criminal force to the sister-in-law of the complainant intending to outrage or knowing it to be likely that he will thereby outrage her modesty and attempted to commit rape upon her and that you thereby committed an offence punishable **under Section 62 of BNS**, and within the **cognizance of this court.**
