State the offence ***Firstly* : -** That on 27.05.2020 at 19.00 hours at Patiram Maa Kali Temple under P.S. Balurghat, District Dakshin Dinajpur you committed rape on the ‘victim lady’ and you have thereby committed an offence punishable **under Section 376 of the Indian Penal Code, and** within the **cognizance of this court.**

***Secondly* :-** That on 27.05.2020 at 19.00 hours at Patiram Maa Kali Temple under P.S. Balurghat, District Dakshin Dinajpur by sending anonymous communication by treating ‘victim lady’ with injury her person and you have thereby committed an offence punishable **under Section 506 of the Indian Penal Code, and** within the **cognizance of this court.**
