**ORDER NO. 09**

Accused person namely Kartick Sarkar @ Bangla is brought under arrest from Hili P.S along with forwarding report, memo of arrest, seizure list, Inspection memo duly endorsed by Medical Officer, Hili Rural Hospital, RAT report and accused challan. Let the documents be kept with the case record.

Accused person namely Kartick Sarkar @ Bangla is taken into custody.

Accused Chanchal Mahanta is produced from J.C. and remanded to J.C till next date.

A bail petition along with Vokatnama is filed for accused person Kartick Sarkar @ Bangla upon serving copy.

Ld. Advocate prays for bail of the accused on the grounds of non-absconsion which is opposed by the Ld. P.P. as the case at investigation stage.

Upon consideration of the submission of both sides and considering the mandatory bar under the provision of NDPS Act, the prayer for bail of accused Kartick Sarkar @ Bangla is hereby rejected.

CD is produced. I.O is present. Heard I.O.

Perused the CD and the forwarding report produced today by the police wherein the police has prayed for Police Custody for the accused Kartick Sarkar @ Bangla for 10 days by SI Goutam Mondal of Hili P.S duly forwarded & recommended by superior authorities on the grounds stated therein and seen by Ld.P.P.

Considering the materials available in the CD, and to recover more contraband narcotic substance, to nab the dealers and associates of contraband narcotic substance and to know the transit route, the prayer of police custody of the accused person namely Kartick Sarkar @ Bangla is hereby allowed for Five (05) days.

I.O. is directed to ensure that utmost care and caution be taken so that the accused person is not manhandled in any manner whatsoever and to provide him with all possible medical assistance if needed, during the period of police remand. The accused person must be taken for medical check up on each day during police remand.

I.O. is further directed to observe strictly the guidelines set out by the Hon'ble Apex Court of India in this behalf regarding police custody in D. K. Basu Vs State of West Bengal (1997) 1 SCC 416.

Accused person namely Kartick Sarkar @ Bangla is hereby remanded to **Police Custody till 20-12-2023.**

To **20-12-2023** for production of the accused person namely Kartick Sarkar @ Bangla from Police Custody with P.C Report along with CD and report in final form.

To 04.01.2024 (vacation intervened) for Production of accused Chanchal Mahanta.
