Accused **Baburam Murmu** is absent by a petition praying for time on the ground stated therein.

Warrant of Arrest is pending against against accused **Bishu Hansda and Sunirmal Lakra**.

The accused **Bishu Hansda** is surrendered before this Court.

He is taken into custody.

An application praying for the bail of the accused is filed.

The application is taken up for hearing.

It appears that the warrant was issued against the accused on 02-09-2022, as his application for adjournment was none moved. He appears to surrender today. The Ld.
