Accused persons three **Swarup Kumar Sarkar @ Tikli, Subrata Khan and Rabiul Mia @ Babu** are physically produced from the J.C.

Ld. Addl. P.P-in-charge Mr. Arindam Chatterjee is present.

Fresh vokatnama with no objection of previous Ld. Advocate is filed on the accused **Subrata Khan**. Let it be accepted and kept in the record.

An application praying for time for hearing of charge is filed on behalf of the accused Rabiul Mia @ Babu.

An application is filed by the prosecution stating that the I.O of the case has intimated that all digital evidence collected during the time of investigation has been submitted in Court and he therefore prays for necessary instruction from the Court for supply of copies of documents to the accused persons.

Scrutinized the record which shows that there are five (05) Compact Disks in the record and the contents of the disks are not verified. However, it appears that these are necessary evidence of the prosecution and they intend to use it at the time of trial.

In such circumstances, the accused are entitled to a copy of such evidences.

Since the evidence relates to digital documents, it would not be proper to merely prepare copies and hand over the same to the accused.

I therefore, find that the System Officer, Dakshin Dinajpur should be directed to prepare copies of the said documents by following due procedure and submit the same in Court, so that copies may be supplied to the accused.

In the above circumstances, it will be necessary to communicate the said order to the Ld. District Judge, Dakshin Dinajpur requesting him to

give necessary instruction to the System Officer for preparation of copies of such documents.

The documents are to be received by the System Officer from Court on proper receipt and copies are to be prepared within a week of receiving such documents so that trial may proceed with.

It must be kept in mind that the accused are in custody.

As complete copies of documents have not yet been provided to the accused charge hearing cannot be conducted today, hence, the application praying for time on behalf of the accused Rabiul Mia @ Babu is allowed.

A copy of this order be sent to the Ld. District Judge for information and necessary instruction upon the System Officer.

A copy may also be served upon the System Officer.
