

State Vs. Jarmanjit Singh alias Mannu BA 181-2025

Present:- Sh. R.S. Walia, Advocate for applicant/accused.

Bail application presented today. It be registered. Notice to APP for the State be issued for 24.07.2025.

Further, APP for the State is directed to apprise the Court, after collecting the necessary information from the Investigating Officer with respect to the filing of any application/petition before any Court, seeking concession of bail under the provisions of Code of Criminal Procedure and the result thereof.

Further, the concerned Ahlmad is directed to verify from the official website of Hon'ble Punjab & Haryana High Court, as to whether any bail application qua the same applicant in FIR/complaint is pending/decided before the High Court or not and the status of the same, if any. After verifying the aforesaid, a report be placed on the case file for the perusal of the Court before next date of hearing in compliance of directions passed by the Hon'ble Punjab & Haryana High Court in CRM-M-52620 (O&M) dated 11.03.2022 titled as 'Kulwant Singh @ SajanVs. State of Punjab'.

Further, the Reader of the Court is directed to append the check list mentioning the following points:-

1. Whether such or similar application for bail has or has been made before any court? In case, the same was made, then its status be also mentioned.
2. Whether the APP for the State has supplied necessary information regarding pendency or decision of any earlier bail application of the accused in the same offence after taking information from the concerned?
3. Whether Ahlmad has given the verification report?
4. Whether the petitioner/applicant was accused in any other case(s) pending against him anywhere in India? In case, it is so, up to date status of proceedings in those cases.
5. If the petitioner is on bail to any case(s) pending against him

or sentence awarded to him in any other case(s) has been made, specific mention is required to be made.

6. Mention number/title of any other pending case against the petitioner/ applicant in the court where such a petition is moved.

7. Whether he has been declared a proclaimed offender in any other case? (in compliance of direction passed by Hon'ble Punjab & Haryana High Court in CRM-M-12816 of 2010 (O&M) dated 26.07.2011 titled as Darbara Singh Vs. State of Punjab.

8. Whether affidavit of the accused/any other person familiar with the facts or interest in the matter is filed regarding pendency of bail application filed by accused in any court and the decision of the earlier bail application? (In compliance of instructions of Hon'ble High Court vide letter no. 5142 GAZ-II. 17 Dated 06.02.2012).

File be now put up on the date fixed alongwith the requisite record and aforementioned report/check list.
