ORDER:

1. This bail application is put up before me being Vacation Judge. This application for anticipatory bail has been moved on behalf of applicant-accused Subhan Ali for offences under Section 306 IPC by virtue of Section 438 Cr.P.C.
2. Notice of this bail application has been given to State. Police record has been requisitioned. Arguments have been heard and record has been perused.

3. As per allegations, complainant Sandeep Kaur W/o. Manpreet Singh is posted as teacher in Govt. Middle School Shergarh Cheema. Manpreet Singh Sandhu was serving as clerk in Govt. High School Pharwali. Her mother-in-law Ranjit Kaur is quite old and he has been residing at home. Complainant has one daughter Shabad Mehar Kaur Sandhu of the age of 4 years and she is studying in Sarvhitkari Vidya Mandir Malerkotla. They all had been living happily in the house. For the last some period Manpreet Singh husband of complainant used to remained under tension. Complainant and her mother-in-law Ranjit Kaur had asked reason for that tension from Manpreet Singh but he did not disclose and he used to say that every thing would be set right. About one and a half month back Manpreet Singh told complainant and her mother-in-law that he had already taken loan from Subhan Ali alias Mani R/o. Malerkotla and he had return some of the amount but Subhan Ali had been demanding money from him. Manpreet Singh had also disclosed that he had also obtained loan from Navjit Singh of village Narike and that amount was also to be returned. Such persons along with Balbir Singh and Gurwinder Singh had been harassing him and they used to raise threats whenever they met him. Mother-in-law of complainant told her that Mani and Navjit Singh used to come at home and they used to raise threats. On that account all the family members used to remain under tension. Complainant and her husband being government employees were avoiding any sort of trouble and on that account they did not file any

application before any authority in order to avoid any loss from such persons.

On 16.05.2023, complainant and her husband had gone to attend their duties and after attending duty they had come back. At that time Manpreet Singh was under great stress. In the evening entire family took meals. Complainant along with her husband and daughter had slept in a room on ground floor. While mother-in-law of complainant was sleeping in another room. In the morning on 17.05.2023 at about 4/5 a.m. complainant Sandeep Kaur woke up and she saw that Manpreet Singh was not present on the bed. Complainant tried to find out her husband on ground floor but Manpreet Singh was not present there. Then Sandeep Kaur went upstairs and she saw that her husband Manpreet Singh hanged himself with the help of lower of black colour with fan and his dead was hanging with that ceiling fan. Complainant disclosed that aspect to her mother-in-law. Police officials were also called at spot. Manpreet Singh had committed suicide being harassed from Subhan Ali, Navjit Singh, Balbir Singh and Gurwinder Singh.

4. There are serious allegations against accused-persons including present applicant-accused Subhan Ali @ Maani that they used to raise threats to Manpreet Singh for getting money back and because of that Manpreet Singh used to remain under stress and on that account he had committed suicide. It is material to mention here that in this case even suicide note was recovered and in such circumstances, applicant-accused

Subhan Ali @ Maani is certainly not entitled to the concession of anticipatory bail as his custodial interrogation is required. Accordingly, his application for anticipatory bail is dismissed. Police record be returned. Bail application file is adjourned to 03.07.2023 for further proceedings.
