**Bail Applications under Section 482 of Bharatiya Nagarik
Suraksha Sahnita, 2023**

ORDER

1. The instant applications preferred U/s 482 of Bharatiya Nagarik Suraksha Sahnita, 2023 for the grant of anticipatory bail.
2. It is alleged in the bail application that applicants are law

abiding citizens. It is further argued that the police of PS Kot Ise Khan and SP(D), Moga and some person of locality are trying to falsely implicate the applicants in some false case. The police of PS Kot Ise Khan/SP (D), Moga are raiding the house of the applicants without any reason. The applicants are having apprehension that they would be involved in some false case and would be harassed and pressurized by the police. The applicants are ready to join the investigation as and when required by this court. Hence, this bail application.

3. On notice of bail application, report from Police Station Kot Ise Khan has been called in which it is stated that as per record neither any FIR is registered against the applicants nor any complaint is pending against applicants Garima Jetly, Gauri Sharma and Shilpa, whereas one local complaint bearing No.270-LPC/PS KIK is pending against the applicants Kuljitpal Jetly and Renu Jetly.

4. Upon notice of bail application, report from office of SP (I), Moga also received in which it is stated that one complaint bearing No.1779/PC-4/25 dated 12.06.2025 was moved by Nishu Gupta son of Mamohan Lal resident of House No.710, Kot Ise Khan, District Moga against the applicants in the office of SSP, Moga and thereafter, same was marked to their office for investigation. The said complaint is still pending for investigation for removal of objections.

5. Since, as per the aforesaid reports, no FIR is registered against the applicants, as such, application under Section 438 Cr.PC for grant of anticipatory bail is not maintainable. Accordingly, the same is hereby dismissed being not maintainable. However, in case on the basis of aforesaid

application/complaint bearing No.1779/PC-4/25 dated 12.06.2025 moved by Nishu Gupta son of Mamohan Lal resident of House No.710, Kot Ise Khan, District Moga, any FIR is registered against the applicants, then seven days prior notice be given to the applicants prior to their arrest. Copy of this bail order be placed in the bail applications titled as State Vs. Gauri Sharma bearing CIS No.BA/1808/2025, State Vs. Shilpa bearing CIS No. BA/1809/2025, State Vs. Renu Jetly bearing CIS No.BA/1810/2025 and State Vs. Kuljit Pal Jetly bearing CIS No.1811/2025. Files be consigned to the Record Room.
