State vs. Manjeet Kaur etc

ORDER

Bail application presented before me in view of office order No. 246 dated 03.12.2025 passed by the office of Ld. District & Sessions Judge, Mansa. It be registered.

This order of mine will dispose of application having been moved by accused Manjeet Kaur @ Lalo and Sandeep Singh @ Gaggi for grant of bail to them in this case. The accused persons/applicants has contended that a false case has been registered against them. It has been submitted that accused persons have been wrongly implicated in this case and that they are absolutely innocent. They further submitted that now they have been arrested. The accused persons/applicants are in custody since 06.12.2025. Hence, prayed for allowing the present bail application.

2. Notice of the bail application has been given to the State. Though the learned APP for the State has not filed any formal reply, but otherwise she contested the claim of the prosecution. Hence, prayed for dismissal of the instant application.

3. I have heard the respective submissions made by the learned APP for the State and the learned defence counsel and have also gone through the record.

4. The accused is facing trial 333, 118(1), 324(4), 190, 191(3) BNS. Since no recovery is to be effected from the accused and her custody is no more required by the police for further interrogation, therefore, no fruitful

purpose shall be served by detaining the accused persons/applicants in judicial custody. It has been held in plethora of authorities that bail is rule and jail is exception. Therefore, in view of the aforesaid discussion of mine, bail application of the accused Manjit Kaur @ Lalo and Sandeep Singh @ Gaggi is considered and allowed in the interest of justice and the accused persons namely Manjit Kaur @ Lalo and Sandeep Singh @ Gaggi are ordered to be released on bail subject to the following conditions:-

- *The applicant shall furnish personal bond in the sum or Rs. 30,000/- each with one surety in the like amount.*
- *The applicant shall not intimidate the witnesses and shall not temper with the prosecution evidence.*
- *The applicants shall join the investigation as and when so directed by the I.O.*
- *The applicants shall not leave the country without prior permission of this court.*

Bail bonds of Manjit Kaur furnished, which are accepted and attested. Release order be issued accordingly. Bail bonds and surety bonds of accused Sandeep Singh not furnished. A copy of this order be sent to Superintendent, District Jail through email-ID. Papers be attached with the main file.
