Accused Md. Faijal is produced from J/C.

Other two accused persons Md. Saidul and Md. Rejabul are not produced before this Court.

Accused persons namely Anwar Ali and Anil Gope on bail are present and have filed an application praying for their extension of Interim bail granted to them. Accused Tapan Gope who is on bail is in custody in connection with other case and a petition has also been filed praying for his extension of Interim bail.

Today is fixed for production and hearing of bail application filed on behalf of the accused persons viz; Md. Faijal and Md. Rejabul.

Ld. Advocate for the accused persons as well as Ld. District PP are present also received intimation from Spl.PP appointed in this case Mr. Bibash Chatterjee praying for permission to attend the bail hearing through VC.

The present case has been forwarded before this court by the Ld. ACJM, Siliguri as this is a case u/s 409 of IPC being triable by Ld. Spl. Court, on 23.12.2025, fixing 06.01.2026, 20.01.2026 and 27.01.2026 for production of the accused persons in custody in connection with this case before this Court.

On 27.01.2026 the accused persons viz; Md. Saidul, Md. Rejabul and Md. Faijal in custody among the three only accused Md. Faijal was produced from custody and the remaining two were not produced.

Direction was given to the Superintendent, Jalpaiguri Central Correctional Home to produce the accused persons viz; Md. Saidul and Md. Rejabul before this Court on this day but no intimation has been received from the end of the Superintendent, Jalpaiguri Central Correctional Home relating to their non production before this Ld.Court on this day.

In the absence of the production of the accused Md. Saidul and Md. Rejabul their petition praying for bail can not be taken up for hearing.

Hearing of the bail petition fixed on this day is adjourned.

Seen the petition filed on behalf of the accused persons praying for transfer of the present case to the Court of the Ld. ACJM Siliguri as there is no material against the accused persons to attract against them the provision u/s 409 of IPC.

Copy served. Let it be kept with the record.

Petition filed on behalf of the accused persons on bail praying for extension of Interim bail is allowed.
