**Order No: 03, dt. 07.03.2026**

The instant Criminal Misc. Case has been filed under Section 482 of BNSS, 2023 filed by the petitioner **Bimalesh Kumar Gupta @ Bimlesh** seeking pre-arrest bail in connection with Matigara P.S. Case No. 90/2014 dated 25.02.2014 u/Ss. 379/411/413/414/34 of I.P.C. corresponding to GR Case No. 509/2014.

Ld. Addl. Public Prosecutor as well as Ld. Lawyer for the accused / petitioner are present.

LCR and case diary tagged along with the LCR are produced.

Misc. Case filed by the petitioner is taken up for hearing.

Heard the Ld. Advocate for the accused / petitioner as well as the Ld. Addl. P.P. for the prosecution.

Perused the LCR and the case diary.

Having heard the submission made by the Ld. Advocate for the accused as well as the Ld. Public Prosecutor for the prosecution from LCR I find that the case was started on 25.02.2014 and from the charge-sheet I find that charge-sheet was submitted in this case vide charge-sheet No. 336 of 2014 dated 31.08.2014 whereas the said charge-sheet was entered in the record on 24.12.2025.

Further from the record I find that it is noted in the order passed dt. 24.12.2025 that record was put up as it was misplaced on the date fixed i.e. 14.03.2014 and the charge-sheet was included in the record on that day.

Charge-sheet dated 31.08.2014 was included in the record on 24.12.2025 i.e. after period of 11 years and if this would be affair of the office of the GRO, ACJM, Siliguri, then the matter is needed to be brought in the knowledge of the Commissioner of Police, Siliguri Police Commissionerate and to also verify whether the charge-sheet was submitted on 31.08.2014 the original charge-sheet register of the year 2014 is also needed to be perused that in fact the charge-sheet was submitted on 31.08.2014.

As such I.C. Matigara P.S. is directed to produce the original charge-sheet register of the year 2014 before this Court for confirmation that the charge-sheet was submitted on 31.08.2014 and for passing further necessary order.

Hearing of the misc.case is adjourned till next date.

Fix **11.03.2026** for production of the original charge-sheet register by the I.C. Matigara P.S., hearing of the misc. case and passing further necessary order.

Case diary tagged along with the LCR be retained.

Let a copy of this order be sent to the Commissioner of Police, Siliguri Police Commissionerate as well as I.C. Matigara P.S. for information and compliance.
