The instant Criminal Misc. Case has been filed under Section 482 of BNSS, 2023 filed by the petitioners **1. Radha Ghosh @ Tabo Ghosh, 2. Rakhi Ghosh, 3. Laxmi Sarkar (Pawan) @ Amina Sarkar, 4. Gira Ghosh @ Giribala Ghosh (Sarkar), 5. Amulya Sarkar, 6. Rajesh Ghosh, 7. Rakesh Ghosh and 8. Raj Balmiki @ Ilu Rajput** seeking pre-arrest bail in connection with Siliguri P.S. Case No. 63/2026 dated 02.02.2026 u/Ss. 126(2)/115(2)/117(2)/118(1)/109(1)/74/79/351(2)/3(5) of BNS corresponding to PTN No. 0349/2026.

Ld. Public Prosecutor as well as Ld. Lawyer for the accused / petitioners are present.

LCR as well as C.D. are produced.

Misc. Case filed by the petitioners is taken up for hearing.

Heard the Ld. Advocate for the accused / petitioners as well as the Ld. P.P. for the prosecution.

Perused the LCR and the case diary.

Having heard the submission made by the Ld. Public Prosecutor and after going through the injury report in the case diary of the victim the nature of injury inflicted is simple in nature and there is no such injury found on the victim sufficient to attract the provision u/S. 109(1) of the BNS. Considering the allegation made against the accused / petitioners in the first information report and the materials in the case diary and as there is no necessity of any custodial interrogation of the accused / petitioners in this case their prayer for anticipatory bail is allowed.

Accused /petitioners namely **1. Radha Ghosh @ Tabo Ghosh, 2. Rakhi Ghosh, 3. Laxmi Sarkar (Pawan) @ Amina Sarkar, 4. Gira Ghosh @ Giribala Ghosh (Sarkar), 5. Amulya Sarkar, 6. Rajesh Ghosh, 7. Rakesh Ghosh and 8. Raj Balmiki @ Ilu Rajput** on the event of their arrest be released on bail executing bond of **Rs. 3,000/- (Rupees Three Thousand) only each with two sureties of Rs. 1,500/- (Rupees One Thousand Five Hundred)**. Bond will be accepted subject to the satisfaction of the arresting officer. Accused / petitioners to comply the provision u/S. 482(2) of the BNSS.

The Criminal Misc Case is thus disposed of.
