Charge sheet is submitted by the I.O of this case vide charge sheet number 411/2024 dated 30.09.2024 against the CCL and others.

Let it be kept with the record.

Now the record is taken up for hearing of bail petition.

Ld. Defence Advocate submits before the Board that there is no bail application filed in respect of the CCL before the Hon'ble Apex Court nor there is any rejection of bail application in respect of the CCL by the Hon'ble Apex Court. Thus the Ld. Advocate for the CCL submits that CCL is a student and prays for bail on any terms and condition.

Ld. PP raised objection.

Heard submission of Ld. Advocate for the CCL as well as the Ld. PP-in-charge.

We have scrutinized the record and considered all submissions.

Considering all aspects, education of the CCL, we are of view that the safety & welfare of above mentioned CCL shall be ensured if he is placed in the protective custody of his mother.

As such bail prayer of the CCL stands allowed.

Mother/guardian of aboved mentioned CCL is declared fit person and the custody of CCL is entrusted upon him, if not wanted any other case.

Mother of the CCL shall furnish A.I. guardian bond of Rs. 1000/- upon condition to ensure safety and welfare of the CCL at all times; ensure not to make any association with bad character persons or para people or to any person acquainted with the facts of the to dissuade him from disclosing to the case so as such fact to the Board or Investigating Officer/any Police Officer.

Call for Social Investigation Report from D.C.P.O, Cooch Behar by next date fixed positively.

Issue Form-5.

Call for SBR from C.W.P.O of Sitalkuchi PS, Cooch Behar by next date fixed positively.

Let a copy of this order be served upon C.W.P.O of Sitalkuchi PS through the O/C of Sitalkuchi PS, Cooch Behar at once.

If on bail, Fix 19-11-2024 for appearence of CCL, SIR, SBR and Notice upon the complainant.

Mother/Guardian of CCL namely Runa Layla Bibi furnished bail bond of Rs. 1000/- on behalf of the CCL which is found fit, correct and accepted.

Release the CCL at once if not wanted any other case.
