The instant Criminal Misc. Case has been filed under Section 482 of BNSS, 2023 filed by the petitioners **1. Amit Ray @ Amit Kumar Ray, 2. Sandip Ray @ Sandip Kumar Ray, 3. Smt. Rinku Roy, 4. Smt. Puja Roy @ Kauslya Roy** and **5. Smt. Pramila Roy @ Pramila Debi Roy** seeking pre-arrest bail in connection with Kharibari P.S. Case No. 173/2026 dated 18.05.2026 u/Ss. 329(4)79/74/115(2)/109/351(3)/3(5) of BNS, corresponding to PTN No. 1698/2026 pending before the Ld. A.C.J.M., Siliguri.

Today is fixed for hearing of Crl.Misc.Case.

Ld. Addl. Public Prosecutor as well as Ld. Lawyer for the accused / petitioners are present.

C.D. is produced. LCR is received.

The record is taken up for hearing of Crl.Misc.Case.

At the outset the Learned Advocate for the accused / petitioners submitted that no application for anticipatory bail has earlier been rejected by the Hon'ble High Court or is pending for disposal before the Hon'ble High Court and he draws attention of this Court to the affidavit affirmed in this respect.

Ld. Lawyer for the petitioners submitted that the petitioners have been falsely implicated in the instant case. It is further pointed out that the allegations are false and baseless and there is no chance of their absconsion and / or tampering of evidence in any manner. Ld. Advocate for the petitioners has prayed for pre-arrest bail on any terms and conditions.

The Learned Addl. Public Prosecutor has submitted that the victim lady has refused for recording her statement u/S. 183 of BNSS and the nature of injury does not indicate the application of Section 109 of BNS.

Having heard the Ld. Advocates appearing on behalf of the parties and on perusal of the FIR and materials on record as well as in case diary and keeping in mind the nature of allegations and further considering the extent of complicity of the accused / petitioners, I find that custodial interrogation of the accused / petitioners is not required, as such I am inclined to allow the prayer for bail as made on behalf of the accused/ petitioners. Accordingly, prayer for pre-arrest bail to the accused / petitioners u/S. 482 of BNSS is considered and allowed.

In the event of arrest the accused / petitioners namely **1. Amit Ray @ Amit Kumar Ray, 2. Sandip Ray @ Sandip Kumar Ray, 3. Smt. Rinku Roy, 4. Smt. Puja Roy @ Kauslya Roy** and **5. Smt. Pramila Roy @ Pramila Debi Roy** be released on furnishing bail bond of **Rs. 5,000/- (Rupees Five Thousand only)** each with **one surety of like amount** to the satisfaction of the arresting officer with conditions laid down in section 482(2) of the B.N.S.S.

The Criminal Misc Case is thus disposed of.
