ORDER BELOW EXH.1

(Passed on 29th July, 2026)

The applicant Nos.1 to 7 have prayed for grant of anticipatory bail apprehending their arrest in Crime No.70/2026 for the offences punishable under Sections 85,115(2),352,351(2), 353(3) r/w.3(5) of Bharatiya Nyaya Sanhita, 2023 registered at Police Station Sindkhed, Dist. Nanded. Upon hearing learned advocate for the accused and learned Addl. P.P. I am satisfied that the accused are entitled for anticipatory bail because custodial interrogation is unwarranted in a case like present nature where offence of cruelty is alleged. Hence, the following order is passed:-

ORDER

(1)	The bail application is allowed and disposed off.
(2)	In the event of arrest of the applicant Nos.(1) Suraj S/o. Rajendra Rathod , (2) Rajendra S/o. Laxman Rathod , (3) Sarla W/o. Rajendra Rathod , (4) Surendra S/o. Rajendra Rathod , (5) Ankita W/o. Surendra Rathod @ Ankita D/o. Sanjay Zodage , (6) Mahindra S/o. Laxman Rathod and (7) Shailendra S/o. Laxman Rathod in Crime No.70/2026 for the offences punishable under Sections 85,115(2),352,351(2), 353(3) r/w.3(5) of Bharatiya Nyaya Sanhita, 2023 registered at Police Station Sindkhed, Dist. Nanded shall be released on P.R. bond of Rs.15,000/- and surety each in the like amount on following conditions :-

	(a)	The applicants shall make themselves available for interrogation by the Investigating Officer as and when required and shall co-operate him.
	(b)	The applicants shall not directly or indirectly make any inducement, threat or promise to any person acquainted with facts of the case so as to dissuade them from disclosing such facts to the Court or to the Police Officer or tamper with the evidence.
	(c)	The applicants shall not commit an offence similar to the offence of which he is suspected.
	(d)	It shall be mandatory for the applicants and their surety to inform the police authorities as well as this Court the change of their residential address while the accused/ applicants are on bail.
	(e)	The applicants shall not leave India without previous permission of this Court.
(3)		Inform concerned Police Station accordingly.
