              Today, the case was fixed for filing supplementary challan.  
Supplementary challan not received.

              An application for exemption of accused person namely  
Parminder Singh Sehgal has been filed which is considered and allowed for  
today only.

              However, another application has been filed by counsel for  
accused for summoning files of two cases i.e. State Vs. Sanjay Jain and State  
Vs. Sarvjit Singh etc. which is pending in the Court of Ms. Raminder Kaur,  
Ld. JMIC, Chandigarh to be tried together with the present case in  
compliance of order dated 15.10.2022 passed by Ld. CJM, Chandigarh.  
Arguments heard .

              Inter alia the contents of application is that applicant/accused  
earlier filed an application before Ld. CJM, Chandigarh for summoning files  
of two cases to be taken up tried, tried and disposed of simultaneously along  
with FIR No.64 dated 23.02.2015 titled as State Vs. Sanjay Jain which was  
pending before the Ld. CJM, Chandigarh. That the said application was  
allowed by Ld. CJM Chandigarh vide order dated 15.10.2022 and three  
cases were ordered to be tried together. In compliance of the said order, all  
the three cases were being tried together in the Court of Ms. Raminder Kaur,  
Ld. JMIC Chandigarh. On the last date of hearing, one case titled as State  
Vs. Parminder Singh etc has been transferred to this Court. It shall be  
apposite to mention here that all the three cases arise from the same  
controversy and properties involved are assets of the same company  
pertaining to which there are allegations and cross allegations and the  
dispute regarding the Farm house would also be subject to the right of  
Sanjay Jain to sell it, the FIRs cannot but be terms as cross cases thus they  
are required to be tried together. At last, it is prayed that the present

application be allowed and the present case to be tried with the two another cases in compliance of order dated 15.10.2022.

Heard. The copy of the order dated 15.10.2022 is also annexed with the present application wherein all the three cases were transferred in the same Court. Considering the facts of abovesaid application as well as order dated 15.10.2022 passed by Ld. CJM, Chandigarh, this Court deems it appropriate to make a reference to Ld. CJM, Chandigarh. Therefore, in the present case, a reference is made to Ld. CJM, Chandigarh to kindly pass an appropriate order in view of the application moved by the accused and in view of the order dated 15.10.2022 already passed by Ld. CJM. Ahlmad is directed to send the present case to the court of Ld. CJM, Chandigarh immediately. Parties are directed to appear before the Ld. CJM Court, Chandigarh on 15.07.2026.
