EXAMINATION-IN-CHIEF BY THE LEARNED SPECIAL P.P.

1. Earlier I was working as senior divisional commercial manager, Bengaluru division, South Western Railway from October 2019 to August 2023.
2. I received a letter from Deputy SP CIO NIA Hyderabad on 04.05.2020 asking for reservation details of 2 passengers i.e Ejaz Pasha and Saleem Khan whether they have travelled by Train No. 11006 originating from Pudhuchery and terminating at Dadar dated 16.10.2019 and Train No. 19567 originating from Tuticorin to Okha dated 01.12.2019. Based on the said request I searched for details from CRIS data base and downloaded the details and handed over to Deputy SP CIO NIA vide my letter dated 06.05.2020.
3. Now I can identify the said documents. Witness identifies forwarding letter. Hence, forwarding letter is marked Ex.P.33. EX.P.33 bears signature of my subordinate i.e Divisional Commercial Manager. Hence the said signature is marked as Ex.P.33. Now I see the downloaded copy of passenger details for Train No.11006 which bears my signature and the same is marked as EX.P.34.

Witness identifies his signatures on each page of EX.P.34. Signature of the witness on last page is marked as Ex.P.34(a).

4. Now I see the downloaded copy of passenger details for Train No.19567 which bears my signature and the same is marked as EX.P.35. Witness identifies his signatures on each page of EX.P.35. Signature of the witness on last page is marked as Ex.P.35(a). Now I see certificate U/s 65B (4) (c) of Indian evidence Act which bears my signature and the same is marked as EX.P.36 and the signature of the witness is marked as EX.P.36(a)

Cross-Examination by learned counsel for the accused No.4,5 and 7 .

Learned counsel for the accused 4,5 and 7 submits no cross examination.

Cross examination by Sri CRP learned counsel for the accused No.3,6,11,16 and 19;

Sri R.K for CRP learned counsel for the accused No.3,6,11,16, and 19 prays time time for cross examination. Prayer rejected. Hence, cross examination is taken as NIL.

Cross examination by Sri S.A learned counsel for the accused No.1,2,8 to 10,12,13,15,17,20 and 22.

Sri C.P for S.A learned counsel for the accused No.1,2,8 to 10,12,13,15,17,20 and 22. prays time for cross examination. Prayer rejected. Hence, cross examination is taken as NIL.
