All the accused who are in custody produced through video conferencing, except accused Manpreet Singh alias Manna, Kapil @

Pandit and Sachin Thapan alias Sachin Bishnoi alias Tuteja, by the various jail authorities. Their production warrants be issued for next date of hearing.

PW 6 SC Baltej Singh appeared and cross-examined partly. His further cross-examination is deferred on request made by defence counsel for want of proper documents with defence. PW 24 SI Gurlal Singh also present and partly examined. His further examination in chief is deferred at the request made by prosecution for want of remaining case property. Parcel containing two pistols having seal impression GS and another parcel containing two pistols having seal impression FSL which were opened during the examination in chief of PW 24, were sealed again, after recording of evidence, with seal impression SS by ASI Shapinder Singh No.3256/LDH from Police station City-I Mansa. Both these witnesses are bound down for next date of hearing. Complete case property be also produced on that date. No other PW is present. PWs Dr. Ashwani Kalia, Insp. Pritpal Singh, Jashandeep Singh served through mobile phones, but not appeared. All these witnesses be summoned alongwith remaining witnesses of the prosecution for 28.08.2026.

Reply to application filed by the defence for supplying electronic record not filed by State. Same be filed on date fixed.

Reply to application moved by Sh. R.S. Behniwal Advocate for issuance of production warrant of accused Anmol Bishnoi from Tihar Jail Delhi for taking him into custody in this case not filed. Reply to this application be also filed on next date of hearing.

Arguments on application under Section 311 Cr.P.C. moved by accused Manpreet Singh @ Mani Raiya for recalling witness PW1 Gurpreet Singh not advanced. Arguments on this application be advanced on next date of hearing.
