Committal Order:-

- 1) Accused named above have been sent up by Station House Officer, Police Station Verka, Amritsar to face their trial under Sections 379-B, 34 and 411 of the Indian Penal Code.

2) Adumbrated in brief facts as per FIR are that on 22.10.2020 when ASI Balwinder Masih, along with ASI Sukhwinder Singh no.1385, ASI Balbir Singh no.1543, Ct. Dilpreet Singh No.125 was present in relation to checking of bad persons on their private vehicle, near Soni Hospital, Verka, Amritsar. Complainant Aarti Kumari w/o Deepak Kumar r/o H. No.17/109, Gali no.03, Mohan Nagar, Verka, Amritsar came present before police and got recorded her statement that complainant is resident of above stated address and is a home maker. On 22.10.2020, she along with her brother Vipin Kumar was returning to her house by walking, after getting dressing of her foot injury, when they reached near Vishav Public School, two unknown young clean shaved persons who were on motorcycle, snatched frocibly from complainant mobile phone make Samsung Y91 which was having number 7986607811 JIO company. On 23.10.2020, complainant again came present before ASI and stated that he mistakenly recorded his statement that mobile phone Samsung Y91 was snatched from him by accused but it was mobile phone of made VIVO company.

3) After Registration of FIR, Police conducted thorough Investigation and on 16.11.2020 accused Raja Singh s/o Bura Singh,

r/o near Janj Ghar, Village Bal Kallan, P.S Kamboh, District Amritsar (Rural) and Santokh Singh s/o Shingara Singh, r/o Village Bal Kallan, District Amritsar were arrested and Mobile phone VIVO Y91 (Black Color) having IMEI No.866951049979716, 866951049979708 were recovered from him vide recovery memo dated 16.11.2020. After completion of the investigation and all other necessary formalities, the challan has been presented in the court.

4) Copies of documents, as required under section 207 Cr.P.C., were supplied to accused Raja Singh and Santokh Singh, free of costs and their separate statement to this effect has been recorded.

5) I have heard learned APP for the State, as well as, learned counsel for the accused on the point of committing case to the court of Sessions.

6) From the perusal of report under section 173 Cr.P.C prima facie an offence punishable under section 379-B (2) IPC inter alia is made out against the accused which is exclusively triable by the Ld. Court of Sessions. Hence, case in hand is committed to the Ld. Court of Sessions, Amritsar for 08.03.2021. Jail Authorities are directed to produce accused Raja Singh and Santokh Singh before Learned Sessions Judge, Amritsar on **08.03.2021** at 10:00 a.m sharp. Public

Prosecutor be duly notified regarding the order. Ahlmad of this Court is directed to send this file, complete in all respects, to the Court of learned Sessions Judge, Amritsar, well before the date fixed.
