

Accused Bikash Biswakarma @ Rajdeep Lohar files a bail application praying for releasing him on bail in connection with this case in terms of order dated 01.09.2023 passed by the Hon'ble Circuit Bench of Hon'ble Calcutta High Court at Jalpaiguri. The bail application is also coupled with one xerox copy of order dated 01.09.2023 passed by the Hon'ble Circuit Bench of Hon'ble Calcutta High Court at Jalpaiguri as well as an affidavit regarding the genuineness of the order of the Hon'ble Circuit Bench of Hon'ble Calcutta High Court at Jalpaiguri and the xerox copy of driving license of the accused Bikash Biswakarma.

It is found from the case record vide order No. 7 dated 29.08.2023 the accused Bikash Biswakarma had also filed another application before this court during the pendency of the bail application before the Hon'ble Circuit Bench of Hon'ble Calcutta High Court at Jalpaiguri. The said bail application filed for the accused Bikash Biswakarma is considered and rejected as not pressed.

Heard the petition filed by the accused praying for passing necessary order in this case in terms of order dated 01.09.2023 passed in CRM (NDPS) 686 of 2023 of the Hon'ble Circuit Bench of Calcutta High Court at Jalpaiguri in presence of Ld. advocate for the accused person and the Ld. Special P.P.

Seen the petition, perused copy of order dated 01.09.2023 of the Hon'ble Circuit Bench of Hon'ble Calcutta High Court at Jalpaiguri passed in CRM(NDPS) 686 of 2023 and considered.

On going through the order of the Hon'ble Circuit Bench of Hon'ble Calcutta High Court at Jalpaiguri dated 01.09.2023, I find that the Hon'ble Circuit Bench of Hon'ble Calcutta High Court at Jalpaiguri was pleased to allow the accused/petitioner Bikash Biswakarma @ Rajdeep Lohar on bail on furnishing a bond of Rs. 10,000/- with two sureties of like amount each one of whom must be local to the satisfaction of this Court under NDPS Act, Kalimpong.

In view of the above, the prayer for releasing the accused person on bail in terms of order dated 01.09.2023 of the Hon'ble Circuit Bench of Hon'ble Calcutta High Court at Jalpaiguri passed in CRM (NDPS) 686 of 2023 is considered and allowed.

Accordingly, the accused Bikash Biswakarma @ Rajdeep Lohar is enlarged on bail on furnishing a bond of Rs. 10,000/- with two sureties of like amount each, one of whom must be local to the satisfaction of this court on condition that he shall meet with the officer in charge, Kalimpong P.S. once in a week and shall attend all hearings before this court until further order and on further condition that he shall not tamper with the evidence and / or intimidate the witnesses and he shall attend this court on all the date as specified for hearing. In the event, he fails to comply with the direction as above without any justifiable cause, this court shall be at liberty to cancel his bail without any further reference of the Hon'ble Circuit Bench of Hon'ble Calcutta High Court at Jalpaiguri.

Let a copy of this order be sent to the Ld. C.J.M., Kalimpong for his information and taking necessary action.

If the accused furnishes the bail bonds before the Ld. C.J.M., the Ld. C.J.M., Kalimpong is directed to make the bail bonds furnished by the accused fit and to transmit the same to this court for its acceptances as well as issuance of release order of the accused Bikash Biswakarma @ Rajdeep Lohar.

Thus, this petition hereby stands disposed of.
