Order No. 08 Dated 16.01.2026

Today is fixed for evidence of C.S.W. No. 10 and appearance of the accused persons.

Out of the seventeen (17) accused persons on Court bail sixteen accused persons namely, Sk. Abdul Rahim @ Sk. Rahim Ali, Sk. Raj, Sk. Rahaman @ Sk. Rahaman Ali, Sk. Arbaj @ Sk. Arbaj Alam, Sk. Sahid Alam @ Sk. Said Alam, Sk. Najimuddin @ Sk. Najimuddin Ali, Sk. Sadek Ali, Sk. Nur Ali @ Sk. Nura Ali, Sk. Samser Ali, Sk. Ansar Ali, Sk. Afsar Ali, Sk. Saidul Ali, Sk. Samedul, Sk. Maidul Ali, Sk. Sahabaj @ Sk. Sahabaz Alam and Sk. Manirul Ali are present by filing hazira. Other one accused person namely, Sk. Kamal @ Sk. Kamal Ali is absent by filing a petition under section 317 of Cr.P.C through learned advocate.

Ld. P.P.in-charge, Satrughna Jana is present and also files hazira.

Ld. Defence Counsel is also present.

Heard. Considered and prayer is allowed.

On compliance of the order dated 13.01.2026 passed by this Court, Officer-in-charge of Khejuri P.S. and I/C of Henria Outpost are present with a written explanation.

Seen. Heard Officer-in-charge of Khejuri P.S. and I/C of Henria Outpost.

Let the same be kept with the record.

One C.S. witness namely, ASI Surajit Kr. Mandal is present today.

ASI Surajit Kr. Mandal is examined on oath as **P.W. 9**, cross-examined in full and then discharged.

The rough Sketch map with index of P.O. are marked as **Exhibit P-5/PW-9 & P-5/1/PW-9 respectively**.

The formal FIR is marked as **Exhibit P-6/PW-9**.

The endorsement of the then O.C in the written complaint is marked as **Exhibit P-1/1/PW-9**.

ASI Surajit Kr. Mandal files an written explanation submitting that on 13.01.2026 he was absent on 13.01.2026 as he went to Contai Court in c/w Khejuri P.S. case no. 666/2025 dated 30.12.2025.

Perused the explanation.

The explanation is not accepted as true fact since O/C Khejuri P.S. appeared in Court and stated that this officer was not engaged in L/O duty on 13.01.2026 but he himself sent a message to this Court that he was busy in L/O duty beyond the knowledge of O/C Khejuri P.S. This witness has made another false written statement in this explanation.

Let the matter be referred to Superintendent of Police, Purba Medinipur for necessary proceeding against him.

Ld. P.P. in-charge files a petition under section 294 of Cr.P.C along with medical treatment sheet of injured/ Rajibul Malida and prays for an order to mark the documents as exhibit as per provision of law.

No objection is raised by learned Defence Counsel.

Hence, the prayer under section 294 of Cr.P.C is allowed in consent.

Let the medical treatment sheet of injured/ Rajibul Malida be marked as Exhibit P-7 collectively (under section 294 of Cr.P.C).

The case is adjourned this day.
