Order No.02, dt. 06.03.2026 :

This is an application u/S-482 of B.N.S.S. moved by the Ld. Advocate for the accused/ petitioners, namely, 1) **Sk Muktarul @ Muktarul Islam** and 2) **Sk Musibur @ Sk Musiul** praying for anticipatory bail.

Ld. Advocate for the accused/petitioners and the Ld. P.P.-in-charge both are found present.

At the outset, learned Advocate for the accused/petitioners submits that no application for anticipatory bail has earlier been rejected by the Hon'ble Court or is pending for disposal before the Hon'ble Court. Learned Advocate draws the attention of this Court to the affidavit relating to such fact. Ld. P.P.-in-charge does not dispute the submission of his ld. counterpart.

Ld. Advocate for the accused/petitioners further submits that victim is the brother-in-law of the accused/petitioners and there is dispute between the parties regarding jewellery business and the victim was not recovered from the custody of the accused/petitioners. It is further submitted that nothing is left to investigate in this case as charge sheet has already been submitted. He, thus, has prayed for anticipatory bail of the accused/petitioners on any condition.

Ld. P.P in-charge refers to the C.D and raises strong objection.

Heard both sides. Considered.

Perused the petition, case record and C.D. as well.

Allegations against the accused/petitioners are serious in nature. Materials available in the C.D. prima facie indicates involvement of the accused/petitioners in the offence alleged. One accused, who has been charge sheeted, approached the Hon'ble High Court while in the custody for grant of bail, which was turned down by the Hon'ble Court. Indeed, investigation is over but considering the gravity and seriousness of the offence and severity of punishment involved, I am not inclined to allow anticipatory bail in favour of the accused/petitioners.

Accordingly, the prayer for anticipatory bail of the accused/petitioners, namely, **Sk Muktarul @ Muktarul Islam** and **Sk Musibur @ Sk Musiul** stands **rejected**.

CrI. Misc. Case stands disposed of.
