Today is fixed for production of accused persons namely Md. Samad and Md. Ibram @ Imran.

Ld. P.P in-charge files hazira.

Ld. Lawyer for the accused persons is also present

02 accused persons, namely, Md. Samad and Md. Ibram @ Imran are produced through V.C. using the link provided by Superintendent, Tamluk sub-Correctional Home in the missive being No.729/AB dated 07.03.2026.

Bail petition filed on behalf of the accused persons is taken up for consideration.

At the outset, it is submitted by Ld. Lawyer for the accused persons that no bail application is pending before the Hon'ble Court nor any such application was filed or rejected by the Hon'ble Court. Ld. P.P in-charge does not dispute such submission of his learned counter part.

Ld. Lawyer has further submitted that his clients are innocent which would be unfolded in course of trial and they have been behind the bar for more than 100 days and charge sheet has been submitted and no useful purpose now would be served in further detention of the accused persons in quod and accused persons have intention to face the trial and if they are granted bail, they would turn up in the Court on every date fixed in the case by the Court. Ld. Lawyer therefore has prayed that accused persons may be granted bail on any condition as the Court may fit and deem proper.

Ld. P.P in-charge has raised vehement objection to the bail prayer of the accused persons and submitted that this is the fit case for custody trial and bail prayer of the accused persons may be rejected.

Perused the petition, record as well as C/D.

Allegations, indeed, are very serious in nature. V.G was seriously injured. However, as investigation is over, no useful purpose would be served in keeping the accused persons in detention further and that too, when they have been incarcerated for a pretty long period of time. I, therefore, find merit in the bail petition of the accused persons which of why their prayer for bail stands allowed but with condition.

The accused persons namely Md. Samad and Md. Ibram @ Imran be released on bail by executing bond of Rs.10,000/- each with two sureties of Rs.5,000/- each, of whom one must be local having property at Tamluk, subject to the satisfaction of Ld. CJM, Purba Medinipur at Tamluk. If on bail, each of the accused persons has to attend the Court on each and every date as fixed in the case.

With these observation, bail petition of the accused persons stands disposed of.

Next date is fixed on **20.03.2026** for production of accused persons, if not on bail, and consideration of charge.
