Today is fixed for production of accused persons, if not on bail, and consideration of charge.

Ld. P.P in-charge files hazira.

Ld. Lawyer for the accused persons is also present

01 accused person, namely Md. Ibram @ Imran is produced before the Court physically from J/C. Another accused person namely, Md. Samad is produced before the Court through V.C. using the link provided by Superintendent, Tamluk sub-Correctional Home in the missive being No.857/AB dated 19.03.2026.

A petition is filed by the accused persons praying for modification of order of bail on the ground stated therein. Along with the petition, photocopy of Aadhaar card of accused Md. Shamshad bearing No. 579274425493 as well as photocopy of Aadhaar card of accused Md. Imran bearing No. 634064401609, being attested by S. Ghosh, Notary, Tamluk, are also filed.

Copy of the petition has been served upon the Ld. P.P in-charge.

Said petition is taken up for consideration.

Heard Ld. Lawyer for the accused persons who has submitted that Court while granting bail to the accused persons has incorporated a condition therein that one of the sureties would be a local person having landed property at Tamluk but accused persons have become unable to find any such local surety and as such bail condition may be modified and they may be allowed to furnish cash surety so that they can have the benefit of bail being granted by the Court.

Ld. P.P in-charge has raised objection to the prayer of Ld. Lawyer for the accused persons.

Perused the petition and record as well.

Considering the state of the proceedings as well as long detention of the accused persons, this Court, despite the seriousness of the allegations, allowed bail to the accused persons subject to the condition that one of the sureties would be local having landed property at Tamluk. Said bail was granted on 07.03.2026. However, as they are unable to find any local surety at Tamluk, they have become unable to come out of correctional home despite having an order of bail in their favour. But then again, to secure the presence of the accused persons before the Court during trial, such a condition has been imposed by the Court and as such, said condition can not be absolutely given a go by. However, in view of the inability of the accused persons to find a local surety at Tamluk, the bail order can be slightly modified to expand the area beyond Tamluk to find such a surety. In view thereof, condition of the bail is modified only to extent that local surety must be a person having immovable property within the jurisdiction of Tamluk Sub-Division. Needless to state, other condition of the bail would remain the same.

Petition accordingly is disposed of.

Ld. Lawyer for the accused persons at this stage has submitted that he could not get himself prepared for hearing on the point of framing of charge and as such further time may be allowed to him for such purpose and to this end, he has filed a petition.

Ld. P.P in-charge has not raised objection to the prayer of Ld. Lawyer of the accused persons.

In view thereof, prayer is allowed. Hearing on the point of framing of charge is deferred till next date.
