Order No.02, dt. 17.03.2026 :

This is an application u/S-482 of B.N.S.S. moved by the Ld. Advocate for the accused/petitioners, namely, **1) Soumitra Das, 2) Dulal Das @ Dulal Chandra Das, 3) Rabin Das @ Rabin Chandra Das, 4) Sambhu Charan Das, 5) Sourav Das @ Sourabh Das, 6) Sujit Das and 7) Tarun Chandra Das @ Tarun Das** praying for anticipatory bail.

Ld. Advocate for the accused/petitioners and the Ld. P.P, Purba Medinipur, both are found present.

At the outset, learned Advocate for the accused/petitioners submits that no application for anticipatory bail has earlier been rejected by the Hon'ble Court or is pending for disposal before the Hon'ble Court. Learned Advocate draws the attention of this Court to the affidavit relating to such fact. Ld. PP, Purba Medinipur does not dispute the submission of his ld. counterpart.

Ld. Advocate for the accused/petitioners submits that charge sheet has been submitted in this case as investigation is over and some of the accused persons have been enlarged on bail and these accused persons are on same footing. Thus, he has prayed for anticipatory bail of the accused/petitioners on any condition.

Ld. P.P, Purba Medinipur refers to the C.D and raises objection.

Heard both sides. Considered.

Perused the petition, case record and C.D. as well.

Investigation is over meaning thereby stage of collection of evidence has ended. Acquisition so levelled are indeed serious in nature. However, as investigation is over and as few of the accused persons are enlarged on bail, no useful purpose now would be served in apprehension of the present accused/petitioners. I, therefore, find no ground to refuse the prayer for anticipatory bail of the accused/petitioners. Accordingly, the prayer for anticipatory bail of the accused/petitioners is **allowed**.

In the event of the arrest of the accused/petitioners namely, **Soumitra Das, Dulal Das @ Dulal Chandra Das, Rabin Das @ Rabin Chandra Das, Sambhu Charan Das, Sourav Das @ Sourabh Das, Sujit Das and Tarun Chandra Das @ Tarun Das**, be released on bail by executing bond of **Rs. 5,000/-** each with two registered sureties of **Rs. 2,500/-** each, subject to the satisfaction of arresting officer and on condition that they shall abide by the provisions as enumerated in section 482(2) of B.N.S.S. and **with further condition that the accused/petitioners shall surrender before the Court of Id. A.C.J.M.-II, Haldia, Purba Medinipur within two weeks from the date of passing of this order, i.d., the order for bail shall automatically stand cancelled.**

Crl. Misc. Case stands disposed of.
