Order No.03 dt. 12.06.2026 :

This is an application u/S-483 of B.N.S.S. moved by the Ld. Advocate for the accused-petitioner, namely, **Arnab Chakraborty** praying for bail.

It is stated in the petition that no other bail petition is filed or pending or rejected by the Hon'ble High Court, Calcutta.

The Ld. Advocate for the accused-petitioner and the Ld. P.P both are found present.

Ld. Advocate for the accused-petitioner submits that the F.I.R. allegation is totally false and stereotyped. This accused-petitioner is innocent and falsely implicated in this case. The accused-petitioner is in custody since 23.02.2026. Considering the long period of detention, the prayer for bail of the accused-petitioner may be allowed.

Ld. P.P refers the C.D and raises objection.

Heard both sides. Considered.

Perused the written complaint, statement recorded u/S-180 of B.N.S.S., inquest report, P.M. report, suicidal note in page no. 38 of the C.D. and other relevant materials available in the C.D. and T.C.R. It appears from the case record that investigation has been completed by submitting charge sheet. The accused-petitioner is in custody since 23.02.2026.

Considering the materials on record, I am of the opinion that further detention of the accused-petitioner is not highly required and accordingly, the prayer for bail of the accused-petitioner is **allowed**.

Accordingly, accused-petitioner, namely, **Arnab Chakraborty** may find bail on executing bond of **Rs. 10,000/-** with two sureties of **Rs. 5,000/-** each, **one of whom must be local**, subject to the satisfaction of Id. C.J.M., Purba Medinipur, i.d. to J/C.

Crl. Misc. Case stands disposed of.

C.D. & T.C.R be returned.

Let a copy of this order, along with the T.C.R., be sent to the Ld. C.J.M., Purba Medinipur for information and necessary action.
