State of West Bengal -Vs.- Buddhadeb Barman

Order No. 01 dated 20.01.2026

Today is fixed for appearance of the accused person and consideration of charge.

Sole CS accused person namely **Buddhadeb Barman** on CB is present by filing hazira.

Ld. P.P. in charge/Dipankar Giri is present.

Ld. Advocate for the accused is also present.

Ld. P.P. in charge initiated proceeding by opening the case of the prosecution u/s. 249 of the **Bharatiya Nagarik Surakhsha Sanhita, in short BNSS** (previously **S.226 Cr.P.C**) describing the charges brought against the accused person **Buddhadeb Barman** for offence u/ss. **329(4)/115(2)/351(2)/76 of Bharatiya Nyaya Sanhita, 2023(in short BNS. 2023)**.

Now, in presence of Ld. P.P. in charge and Ld. Defence Counsel, the record is taken up for framing of charge.

Perused the case record as well as FIR, charge-sheet, the statement of witnesses under Section **180 of B.N.S.S (previously S. 161 of CrPC)** and the documents produced.

Upon perusal of material and report under Section 193 of B.N.S.S (previously **S.173 CrPC**), this court is of considered view that there is sufficient material for commission of offence punishable u/ss. **329(4)/115(2)/351(2)/76 of Bharatiya Nyaya Sanhita, 2023(in short BNS. 2023)** against accused person namely **Buddhadeb Barman**.

Accordingly charge is framed against the accused person, namely, **Buddhadeb Barman** punishable u/ss. **329(4)/115(2)/351(2)/76 of Bharatiya Nyaya Sanhita, 2023(in short BNS. 2023)**.

The contents of the charge are read over and explained to the accused person in language of Court and in their own language and on being asked, the accused person pleaded not guilty by saying individually 'Ami Nirdosh' and claimed to be tried.

The charge form of four head is duly filled up by this court and is kept with the record as a part of this case record.

04.06.2026 for evidence of CSW 8

Prosecution is directed to submit detailed case calendar before trial begins and accused person(s) has/have given liberty to file application under section **254 of the BNSS** (previously **S.231 of the Cr.P.C**) before preparation of case calendar in accordance with the decision of the

Prosecution is to take step to bring the witnesses. Issue summons.

I.O must be present on every dates during trial, ensure production of witnesses and shall assist the Learned Public Prosecutor. Seized alamats be produced each day of trial. Inform I.O.
