Iusuf Ali for the offences punishable under Section 376/511 of IPC & in addition I have also found prima facie sufficient material to frame charge against all the accused persons, namely, 1) Sk. Soleman Ali and 2. Sk. Yusub Ali @ Sk. Iusuf Ali, 3. Rinki Bibi @ Murshida Bibi, 4. Musibul Nayek @ Musiur and 5. Aminuddin Din for the offences punishable under Section 341/448/323/325/506/34 of IPC. Accordingly, charge is framed against these accused persons.

The substance of accusation of charge is read over and explained to the accused persons in Bengali to which they pleaded “not guilty” by saying “Amra Nirdosh” individually and claim to be tried.
