Today is fixed for production and consideration of charge.

Accused Sk. Firoj is produced from JC, placed on dock and remanded to JC till date.

An application for bail has filed on behalf of the accused.

It is submitted that no bail petition is pending or rejected before Hon'ble High Court, Calcutta. present by filing hazira.

Learned Chief PP and Ld. Defence Counsel are present.

Now the record is taken up for hearing of bail application.

Heard both sides.

At the time of hearing Ld. Defence Counsel submitted that the accused has three years baby. So, he has prayed for bail.

On the other hand, Ld. Chief PP raised strong objection mentioning the allegation against the accused.

On scrutiny of the materials on record, it appears that charge sheet was submitted u/sec. 354C/354D/406/420/500/509/376 of IPC and section 66E/67A/37 of I.T.Act.

After considering the gravity of offence, this court is not inclined to allow the instant petition.

Hence the petition for bail in respect of accused Sk. Firoj is hereby **rejected**.

Now the record is taken up for consideration of charge.

Heard both sides.

Perused the materials on record as well as in the C.D.

After careful perusal of the case record and C.D, I have found prima facie sufficient material to frame charge under sections 354C/354D/420/506/376 of IPC & section 66E & 67A of I.T.Act against the accused person/Sk. Firoj. Accordingly, charge is framed against this accused person.

The substance of accusation of charge is read over and explained to the accused persons in Bengali to which he pleaded "not guilty" by saying "Ami Nirdosh" individually and claim to be tried.
