Order No. 01 dated 08.07.2024

Today is fixed for appearance and consideration of charge.

All five C.S accused persons namely, 1) Sk. Amjadul @ Gura, 2. Taslima Bibi, 3. Sk. Kurban, 4. Mst. Sahida Bibi & 5. Gulenoor Khatun on Court bail are present by filing hazira.

Ld. P.P. in charge is present.

Ld. Advocate for the accused is also present.

Ld. P.P. in charge initiated proceeding by opening the case of the prosecution u/s. 226 Cr.P.C. describing the charges brought against the accused persons namely **1) Sk. Amjadul @ Gura, 2. Taslima Bibi, 3. Sk. Kurban, 4. Mst. Sahida Bibi & 5. Gulenoor Khatun** for offence u/ss. 498A/304B/306/34 of I.P.C.

Now, in presence of Ld. P.P. in charge and Ld. Defence Counsel, the record is taken up for framing of charge.

Perused the case record as well as FIR, charge-sheet, the statement of witnesses under Section 161 CrPC and the documents produced.

Upon perusal of material and report under Section 173 CrPC, this court is of considered view that there is sufficient material for commission of offence punishable u/s. 498A of I.P.C & section 304B/306/34 of IPC against accused namely 1) **Sk. Amjadul @ Gura**, 2. **Taslima Bibi**, 3. **Sk. Kurban**, 4. **Mst. Sahida Bibi** & 5. **Gulenoor Khatun**.

Accordingly charge is framed against the accused persons, namely, **1) Sk. Amjadul @ Gura, 2. Taslima Bibi, 3. Sk. Kurban, 4. Mst. Sahida Bibi & 5. Gulenoor Khatun** punishable u/s. 498A of IPC and section 304B/302/34 of IPC.

The contents of the charge are read over and explained to the accused persons in language of Court and in their own language and on being asked, the accused persons pleaded not guilty by saying individually 'Ami Nirdosh' and claimed to be tried.

The charge form of three heads is duly filled up by this court and is kept with the record as a part of this case record.

Prosecution is directed to produce witnesses in accordance with the decision of the Hon'ble Supreme Court in **Rajesh Yadav and Another V State of Uttar Pradesh** reported in (2022) 12 SCC 200.

Prosecution is to take step to bring the witnesses. Issue summons.

I.O must be present on every date during trial, to ensure production of witnesses and shall assist the Learned Public Prosecutor. Seized alamats be produced each day of trial. Inform I.O.
