Today is fixed for appearance and consideration of charge.

All the three accused persons namely, Suman Panja, Gosta Behari Bhowmik and Malini Mal on Court bail are present by filing attendance.

Accused Mirja Miyaraj Begg appears and wants to surrender himself before this Court by filing a petition. V. nama is filed.

Record shows that the case was filed for the present against the said accused on 30-09-2024.

Accordingly, he is taken into custody and remanded to J/C.

Recall W/A, if any.

Record is taken up for consideration of charge.

Heard Ld. Additional PP Manjur Rahaman Khan and Ld. Lawyer for the accused.

On perusal of the case record it appears that there is sufficient ground to presume that accused persons have committed offence punishable under Section 409/468/471/120B of IPC.

Accordingly, charge under Section 409/468/471/120B of IPC is framed against accused persons, namely, Suman Panja, Gosta Behari Bhowmik, Malini Mal and Mirja Miyaran Begg.

The charge, so framed, is read over and explained to the accused persons, to which each of them pleaded not guilty by saying separately 'Nirdosh' and claimed to tried.

The charge, so framed, be kept with the record in separate sheet.

The bail application filed on behalf of accused Mirja Miyaran Begg is taken up for hearing.

Ld. Lawyer for the accused submitted that due to unavoidable circumstances the accused person could not appear before this Court and W/A was issued against him. It is submitted that he will not misuse his liberty of bail in future and prays for his release on bail.

Ld. Additional PP submits that the accused has already misused the liberty of bail and raises objection to his prayer for bail.

Heard both sides. Considering the fact that the accused was shown

as absconder in the charge sheet and was not arrested during the course of investigation and on further consideration that he has not misused the liberty at any earlier state and there is no prayer for custody trial, I am inclined to allow bail application of the accused.

Accused, namely, Mirja Miyaran Begg is directed to be released on bail on furnishing bail bond of Rs.10,000/- with two registered sureties of Rs.5,000/- each, subject to the satisfaction and acceptance of the Ld. A.C.J.M, Contai i/d to J/C till the next date.

If on bail, to date for appearance.

Fix **29-01-2026** for appearance and evidence of CSW-1.

Issue summons to the witness.

Ld. Additional PP to take steps.
